Number of employees with a university degree (PhD students excluded) engaged in research and development and their full time equivalent work capacity (FTE) in 2003, 2004, 2005, 2006 and average number during the assessment period In 2003, at the Institute of Political Science of the Slovak Academy of Sciences (IPS SAS) there were 14 employees with a university degree engaged in research and development, which averaged 11 FTE. In the following year there were 15 employees averaging 12.5 FTE. In 2005, there were 17 employees with a university degree averaging 10.7 FTE. In the last monitored year there were 19 employees averaging 12.5 FTE. Over the four years (2003-2006), the average number has been 16.25, which is equivalent to 11.68 FTE.

II. General information on the research and development activity of the Organisation:

1. Mission Statement of the Organisation as presented in its Foundation Charter

The Institute of Political Science was established on 1 March 2002 as a result of transformation of the Cabinet of Politology of the Slovak Academy of Sciences in compliance with Resolution No. 14 of the Presidium of the Slovak Academy of Sciences with the effect from 1 February 1990.

The mission of the Institute of Political Science of the SAS is basic research into political relations and processes within their internal and international political contexts.

The Institute focuses on conducting studies in the area of international relations and political systems, the history of political thought, the research methods of political sciences and recent political history.

The work of the team of internal and external researchers in collaboration with both domestic and foreign institutions aims at interdisciplinary and multidisciplinary research into political activities, their selected aspects, especially social, nationality, psycho-political and historic; such is also the nature of its synthesising outcomes.

2. Summary of R&D activity pursued by the Organisation during the assessed period, from both national and international aspects and its incorporation in the European Research Area (max. 10 pages)

IPS SAS was established in 1990 as the Cabinet of Political Science SAS. In 2002, it was granted the status of an institute and, as a result, it was renamed into the Institute of Political Science SAS. In the course of its existence, the following areas have been identified in its activity which the institute deals with continuously:

- I. Research into the political system of Slovakia before 1989;
- II. Research into the political system of Slovakia after 1989;
- III. Slovakia's foreign policy and international relations following the country's entry into EU and NATO;
- IV. The history of political thought in Slovakia with the emphasis on the research on individual personalities of the Slovak politics;
- V. The focus on theoretical aspects of research into political science.

The last-mentioned area presents a new element in the research orientation of the institute. By accentuating its development, we have also complied with the demands of the accreditation commission from the recent accreditation in 2004. Its development is particularly due to the efforts of young research and development workers and doctoral students. We also strive to draw the attention of IPS SAS intramural and extramural doctoral students to the given area to stimulate their choice of the related issues as a subject of their doctoral theses.

In the period immediately preceding the transformation of the Cabinet of Political Science into institute, the institute's work still bore the features of methodological approaches resulting from the history of the institute, which was established with the aim to produce analysis of the historic events of the period of 1967-1970. Therefore, along with the line of research into political science, research on contemporary history has been formed as well.

The institute decided for the interdisciplinary or rather multidisciplinary approach to its research. This influenced the structure of research teams participating in the completion of the projects. It has to be pointed out however that, due to severe understaffing, the institute had to engage experts from other SAS institutes, universities, state administration and non-state institutions into the work on research projects. Knowledge gained from the findings of individual VEGA projects found its application in the work on four projects of state research and development programs in 2003-2005, where in the first two, the IPS SAS played the role of the main project solver:

Participation in the above-mentioned projects of state research and development programs has contributed to certain reprofiling of the institute, when, compared to the previous period, the focus of its work has shifted from the subjects related to the problems of the past to contemporary issues. At the same time, due to the engagement of a whole host of other research institutions with humanity profile in the projects of state research and development programs, IPS SAS has become an important conceptual and coordination centre of political science research in Slovakia. As the only humanities institute of SAS, IPS SAS has managed to win two state research projects.

During the work on the state program "Ideové zdroje a línie slovenskej politiky" (Ideological sources and currents of Slovak politics), cooperation with universities and faculties gained a new quality, when a number of different institutions officially participated in the basic research of IPS SAS: Faculty of Political Science and International Relations UMB Banská Bystrica, Department of Political Science, Faculty of Philosophy, Prešov University in Prešov, Department of Political Science and European Studies, Faculty of Philosophy, UKF Nitra, Department of Political Science, Faculty of Philosophy UCM, Trnava, Department of Political Science, Faculty of Philosophy UCM, Trnava, Department of Political Science, Faculty of Philosophy Comenius University, Bratislava and Department of Political Science, TUAD, Trenčín. In addition to experts from the abovementioned organizations and SAS institutes, IPS SAS managed to engage in its research work also external co-workers – experts from the decision-making bodies and NGOs.

Within the project "Transformácie identít v súčasnom a historickom kontexte Slovenska so zreteľom na integračné procesy" (Transition of identities in the contemporary and historical context of Slovakia with the main focus on the processes of integration), IPS SAS managed to involve in its research activities doctoral students and young research workers and establish an extensive interdisciplinary and multidisciplinary team of young workers and doctoral students under 35, dealing with the problem of identities in different academic institutions of SAS, universities and non-state research institutions.

Methodological approaches have also undergone fundamental changes, when in the IPS SAS research activity methods of empirical research into public opinion conducted in cooperation with the Slovak Radio Media Department began to prevail over the previous approaches. These enabled the institute to build a unique knowledge database documenting citizens' attitudes to current political, economic and social issues in Slovakia.

The new profile of the institute has reflected in the structure and scope of publication activity; over a period of three years 2003-2006, its research workers published or edited 18 book monographs issued in Slovakia, 5 monographs issued abroad and 6 collections of studies from both domestic and international academic conferences.

I. Research into political system of Slovakia before 1989

This line of research on the floor of IPS SAS in the relevant period was carried out primarily under the umbrella of the VEGA grant project of the Ministry of Education and

SAS – "Štátny socializmus a Slovensko) (1948-1989)" (State socialism and Slovakia. 1948-1989. The main academic output was a collection of studies Kmet', N. (ed.) "Pocta Jozefovi Jablonickému" (Homage to Jozef Jablonický). In the same period a two-volume publication was issued entitled Jablonický, J.: Samizdat o odboji. (Štúdie a články) (Samizdat on resistance. Studies and articles). Further outputs of interdisciplinary nature following on from the previous research work of IPS SAS were collections of studies Kmet', N.; Marušiak, J. (eds.): Slovensko a režim normalizácie (Prešov 2003) (Slovakia and the process of normalisation) and Pekník, M. (ed.): Česká a slovenská společnost v období normalizace – Slovenská a česká spoločnosť v čase normalizácie (The Czech and the Slovak society in the period of normalisation – the Slovak and the Czech society in the period of normalisation). (Bratislava 2003).

The project solvers have contributed to broadening the knowledge base by delving deeply into the lives of Emil Tomeš, Jozef Juráš and Laco Novomeský. Besides, the institute also focused on the study of ethnic minorities, particularly on the Hungarian and Polish minority nationalities. With regard to the normalization period, we turned our attention to the relation between power and dissent and other emerging independent groups of population. Resistance of the population against regime was epitomized by religious people and their ways of obtaining religious literature. A further area of interest was awareness development process among the population claiming Hungarian nationality. The aim of the research workers was to contribute to understanding of the relation between the communist regime and religion, to the explication of the concept of people's democracy. We have also pointed out how, in the 1970s and 1980s, the communist regime distorted the heritage of anti-fascist resistance and the Slovak National Uprising. Further research areas included democratic exile and the coming to terms with the communist past.

In 2004, Dr. J. Jablonický, Mgr. N. Kmeť, and Dr. M. Pekník spoke at the international academic conference on the 60th anniversary of the SNU "Slovenské národné povstanie 1944 – súčasť európskej antifašistickej rezistencie v rokoch druhej svetovej vojny" (The Slovak National Uprising of 1944 – integral part of the European anti-fascist resistance in the years of WWII) co-organized by IPS SAS. Dr. J. Jablonický spoke about the SNU and the second resistance in 2004 in Geneva, Basel and Zurich. He also delivered his paper on the anti-fascist resistance at the Czecho-Slovak seminar in Liberec. In 2003, Mgr. J. Marušiak, PhD. published a study in a book publication dedicated to sovietization of Romania and Czechoslovakia. In March 2005, he took part in a meeting of young Czech and Slovak research workers held in Třešť. The organizers of the event were SAS and ASCR.

Mgr. N. Kmeť and Mgr. J. Marušiak actively participated in an international academic conferece "Medzi vynúteným priateľstvom a naozajstnou solidaritou: Česi – Poliaci – Slováci 1938/39 – 1945 – 1989"(Between the forced friendship and real solidarity – Czechs, Poles

and Slovaks 1938/39-1945-1989) held in November 2004 in Wroclaw, organizers: Uniwersytet Wrocławski – Instytut Historii, Instytut Pamieci Narodowej – Wrocław branch office, The institute of current history ASCR.

In 2004, IPS and the project solvers (V. Čelko. N. Kmeť and J. Marušiak) actively participated in the preparation of an international academic conference "The Helsinki Process and the Demise of Communism" held on 5-7 June 2005 at the Ministry of Foreign Affairs of the Czech Republic in Prague. The report was presented by Mgr. J. Marušiak.

During the work on the project, cooperation with the KARTA Institute headquartered in Warsaw ran in parallel with the work on the "Słownik dysydentów (1956-1989)" (A dictionary of dissidents). The result of our cooperation was, besides some biographical entries of persons working for dissent and other independent initiatives, a study by Mgr. J. Marušiak and Mgr. N. Kmeť published on a webpage of the KARTA institute.

In 2005, Mgr. N. Kmet' spoke at several international conferences such as "Czechoslovakia 1945 – at the turning point of the epochs of curbed freedom" organized by USD ASCR and NA CR in May, 2005. In October 2005, he spoke at an international conference held under the title "The red wall is falling" organized by The Epoch Times daily paper and the Conservative Institute of M.R. Štefánik. In September 2005, Mgr. N. Kmet' delivered a presentation in Martin at the conference "Spiritual Values for Today", organized by the Lutheran Congregation in Martin and Lutheran media program Bratislava, Society for Creative Work etc.

At present, IPS SAS is working on another VEGA project "Komunistická moc na Slovensku – jazyk a prax". (The Communist power in Slovakia – language and practical reality)), No. 2/6120/26 (2006-2008). The findings include a monograph Jablonický, Jozef: Samizdat o odboji : štúdie a články II. (Samizdat on resistance: studies and articles II.) Bratislava, Kalligram 2006, 710 p. ISBN 80-7149-781-9 and other publications, issued as part of collective monographs or published in academic and expert journals.

II. Research into the political system of Slovakia after 1989

In 2003, as part of the research into the political system of Slovakia after 1989, a monograph was published entitled *Sopóci, Ján: Politika v spoločnosti (Politics in Society)*. The media area became a new dimension in the institute's work in 2002, when the (VEGA) project "*Slovenská politika a masmédiá po roku 1989"* (01/2002-12/2004) (*The Slovak politics and mass media after 1989*) was approved by the Grant Agency of the Ministry of Education SR and SAS. Based on the "Framework agreement on cooperation between IPS SAS and the Slovak Radio Media Research Department", extensive empirical research was carried out, which had formerly been unfeasible for IPS SAS due to the lack of financial resources.

Systematic orientation of IPS SAS towards research into the political system of Slovakia set in a broader international framwork is also documented by one of the latest monographs of the institute *Krejčí*, *Oskar: "Nová kniha o voľbách"*(*A new book on elections*), published immediately before the parliamentary elections in 2006.

While working on the projects of state research and develpment programs, we focused our attention on the mapping of attitudes of the population of Slovakia to particular issues of the development of political system in Slovakia. In 2006, a publication was issued on this subject: *Pekník Miroslav (ed.): Verejná mienka a politika. Historické vedomie slovenskej spoločnosti. (Public opinion and politics. Historic awareness of the Slovak society).* Bratislava, VEDA – Publishing House of SAS 2006. Further empirical research concerned the issue of inter-ethnic relations in Slovakia, the degree of civic participation and solidarity, as well as the devlopment of social, natinal, regional and political identities. In this respect, it is necessary to emphasise doctoral thesis by *Mgr. Boris Benkovič "Obraz Rómov vo vybraných slovenských médiách" (The image of Roma in the selected Slovak media)* defended in September 2004, which was submitted for the internal use of President of the SR Ivan Gašparovič. The problem of inter-ethnic relations was also analysed in a monograph *Kiss, Jozef: "Irodalom – társadalmi - politikai erötérben"*. NAP KIADÓ. Dunaszerdahely 2004, 118. p. ISBN 80-89032-41-9.

In the course of 2004-2005, IPS SAS repeatedly presented partial findings of empirical research into public opinion conducted jointly with the Slovak Radio Media Research Department, in which it also responded to current political events (e.g. Slovakia's entry into NATO and EU, presidential elections in 2004, elections into the European Parliament 2004 etc.). Decision-making bodies showed their preeminent interest in the research findings.

III. Slovakia's foreign policy and international relations following the country's entry into EU and NATO

After the establishment of the independent Slovak Republic, this area of research became particularly pressing. The institute focused not only on bilateral relations of the SR but also on Slovakia's integration into multilateral groupings. Emphasis was put on monitoring the processes and capturing developmental trends in the time span encompassing the whole period of transformation in Slovakia.

The result of cooperation with the "Jan Masaryk Centre of international studies" at the Faculty of international relations at the Institute of Economics in Prague was an international academic conference on mutual Slovak-Czech relations after 1993 held under the title "Slovensko-české vzťahy v kontexte strednej Európy (The Slovak-Czech relations in the

context of Central Europe) held on 11-12 December 2002 in Bratislava. From the conceptual perspective, the main ambition of the conference was to overcome the existing approach directed at processing particular aspects of mutual relations. Besides Slovak and Czech academic workers, experts from Austria, Holland, Hungary, Poland and Ukraine took part in its preparation and materialization, whereby the desired Central European perspective found its application. The work resulted in a collection of studies, which was – in a revised and completed form - published in 2005 in the VEDA Publishing House as an independent volume.

In the security area, IPS SAS followed on from the long-term cooperation with the Ministry of Defense SR, Ministry of Foreign Affairs SR and the Slovak Foreign Policy Society. As a result, two volumes of NATO documents were issued – "Euroatlantické partnerstvo. NATO v dokumentoch 1990-1999" (The Euro-Atlantic partnership. NATO in the documents of 1990-1999) Bratislava 2000 and "Partnerstvo pre 21. storočie. NATO v dokumentoch z rokov 1999-2001" (Partnership for the 21 century. NATO in the documents of 1999-2001) Bratislava 2002. The third volume of this edition – "Európska bezpečnosť: Strategické partnerstvo NATO a EÚ. Dokumenty NATO z rokov 2002-2004" (European security: Strategic partnership of NATO and EU. NATO documents from 2002-2004). Bratislava, 2006, 496 p. was, based on the signed agreement, produced as a joint research output of the Institute of State and Law SAS.

The issue of integration efforts of the Slovak Republic to enter NATO was analyzed in the publication of IPS SAS by Čurda Jiří, Zatlkaj Pavol: "Cesta Slovenska do NATO" (Slovakia's Road to NATO). In connection with research into security problem, IPS SAS issued a monograph Cigánik L'ubomír JAŠŠOVÁ, EVA: "Terorizmus – od komunikácie s aktérom teroru pri oslobodzovaní rukojemníkov až po opatrenia štátov v boji proti nemu". (Terrorism – from the communication with the terrorist during the liberation of hostages to the measures adopted by countries in the struggle against it). Bratislava: Veda, 2006. 373 p. ISBN 80-224-0892-1. This work presents the institute's response to current challenges in the area of national and global security. For the internal use of the Ministry of Foreign Affairs SR, publication by Zuzana Poláčková "Inštitucionalizácia menšinových práv po 1. svetovej vojne a Spoločnosť národov"(The institutionalisation of minority rights after WWI) was compiled.

In addition to the publications mentioned above, several collections of studies have been prepared for print as a result of the projects of state research and development programs as well as projects conducted within the VEGA grants. Collections of studies "Integračné a dezintegračné procesy v strednej Európe;"(Integration and disintegration processes in Central Europe)" and "Transformácie zahraničnopolitických priorít SR po vstupe do EÚ" (Transformations of foreign policy priorities of SR following its entry into EU) as well as a collection of studies on bilateral relations between SR and the neighbouring states have

been put in print.

Already printed publications include a monograph *Mojžita Miroslav "Formovanie slovenskej diplomacie v rokoch 1990 až 1993. Kňažko – Demeš – Kňažko" (The formation of Slovak diplomacy in 1990-1993. Kňažko – Demeš – Kňažko).* The findings of empirical research into public opinion on the issues of the foreign policy of SR and integration into Euro-Atlantic structures were analysed in the monograph *Pekník, Miroslav a kol.: "Verejná mienka a politika. Medzinárodné vzťahy a zahraničná politika Slovenskej republiky" (Public opinion and politics. International relations and foreign policy of the Slovak Republic) Bratislava, 2005.*

IV. The history of political thought in Slovakia with research emphasis on individual personalities of the Slovak politics

If we want to clarify political developmental trends and relations and to make prognostic conclusions, we have to evaluate historical roots and background of the social processes. This is why we decided to turn our attention to the selected issues of the history of political thought in Slovakia in the 19th and 20th centuries. Reserach on individual personalities of the Slovak politics allows us to integrate the research potential of several institutes specialising in areas such as history, political science, philosophy, international relations, economy. IPS SAS has followed on from research conducted in the previous years and developed on its findings.

Of all remarakble personalities in the Slovak politics, IPS SAS has particularly focused on Alexander Dubček, Milan Hodža, Ladislav Novomeský and Vavro Šrobár. The institute was an expert guarantor of different academic events with international participation dedicated to these personalities. On several occasions, it acted as a partner of the highest constitutional bodies, which took patronage over their organization. Presentations from the above-mentioned events were compiled into studies and published or put in pint.

V. Orientations toward theoretical research aspects in the political science

Orientation towards the theoretical research aspects of political science on the floor of IPS SAS has taken the form of interdisciplinary and multidisciplinary studies. The most significant results in this area are the following works: *Krejčí*, *Oskar: "Politická psychologie"and "Geopolitics of the Central European region. The view from Prague and Bratislava"*. One should not forget to mention a monograph by doctoral student *L'ubomír Blaho "Sociálna spravodlivosť a identita"(Social justice and identity)* or doctoral thesis by *Daniel Šmihula "Štát a medzinárodný systém. História a súčasnosť. (The state and the*

international system. Past and present) "Young research workers and doctoral students paid special attention to theoretical aspects of political science within the state project program "Transition of identities in the contemporary and historical context of Slovakia with the main focus on the processes of integration" Besides a whole host of events organized within the project, one should not omit to mention the publication of an interdisciplinary volume MARUŠIAK Juraj – FERENCOVÁ Michaela (eds.): Teoretické prístupy k identitám a ich praktické aplikácie.(Theoretical approaches to identities and their practical applications). Seminar proceedings. Bratislava, VEDA, Publishing House of SAS 2005, 220 p. ISBN 80-224-0843-3. Another collection of studies from the above-mentioned project is prepared for print.

3. Concept of R&D activity of the Organisation for the next four years (max. 5 pages)

i. Present state of knowledge and status of ongoing research related to the subject of the Concept, from both international and national perspective

In the previous part, the report focused on research into all areas of interest of the institute. The institute's research workers involved in research activities have contributed to deeper understanding of the explored subjects both at the national and international levels. The evidence is the researchers' participation in the international conferences, the number of scientific publications as well as the interest of media in the opinions of the institute's staff on the crucial issues of domestic and foreign policy. In our reseach activities, we will keep putting emphasis on the interdisciplinary and multidisciplinary approaches with the main focus on methodological aspects.

With regard to research into contemporary history after 1989, we intend to enhance contacts particularly with the Institute of Contemporary History of the Czech Academy of Sciences with the parallel application and mutual interaction of historiographic and political science approaches. In this context, we intend to apply a more focused approach to gaining information through oral history, the use of which has been largely missing in Slovakia.

ii. Organisation's role or significance in the overall research effort within the field of the Concept on both the national and international scales

Since the undertaken projects have been jointly participated by most political science institutes in Slovakia, the Institute of Political Science SAS has played the role of the political science research coordinator. Such were National Research Programmes, VEGA projects or organized conferences and academic events. We have signed agreements with the majority

of political science institutions in Slovakia; these agreements serve as the basis for their joint activities.

We have also concluded agreements with some of the research institutions in the Czech Republic - the Institute of Contemporary History of the Czech Academy of Sciences; the Department of History and Civic Education, Faculty of Education, Technical University, Liberec; the Academy of Political and Social Sciences, Kolín; the Jan Masaryk Centre for International Studies, Faculty of International Relations, University of Economics, Prague and the Institute for Central and Eastern Europe and the Balkans, the Faculty of Political Science, University of Bologna in Italy.

Dr. Zuzana Poláčková, research worker of the insititue, is the manager of the project "Die Stellung der Minderheiten in der ČSR, in Osterreich und in Ungarn zwischen beiden Weltkriegen," conducted jointly with the Austrian Academy of Sciences.

In addition to cooperation at the project level, a more regular organization of discussion forums on partial problems in cooperation with international partners, particularly in the field of methodology, appears to be increasingly necessary.

iii. Objectives of the Concept

Research into political system after 1989 will be the institute's primary concern in the following period. Based on the interdisciplinary and multidisciplinary approach, we will try to integrate particular research areas into the above-mentioned major research objective.

It appears that, during the analysis of the political system and assessment of the theoretical and ideological groundwork of the formation of political scene in Slovakia, the search for the interconnectedness and interaction between the traditions of party policy in Slovakia, its innovations and impulses drawn both from the modern concepts of political and social sciences and from international praxeological models have either been little emphasised or even underestimated. What has also been neglected is the generalization of findings gained from the practical work of political subjects. This applies both to the self-reflection of political subjects regarding their own program-making activity and the reflection of the broader cognitive activity in the area of social sciences.

From the current perspective we need to study whether or not, and if so then how much, following the change of the regime in 1989 (i.e., at the dawn of democratic and pluralist party system), drawing knowledge and impulses predominantly from the democratic states of Western Europe and North America led to the automatic adoption of their models and how much room was left for the understanding of domestic peculiarities. The daunting nature of the task resulted both from the previous absence of research into political science and from the lack of experience with the open society. Confrontation of the meaning of the concepts in use and the evaluation of the political spectrum in Slovakia in the process of

creation of the party political system with the political science expertise in the developed democracies is very important, particularly with regard to the creation of conditions for the integration processes in Czechoslovakia and/or Slovakia. It is necessary to understand and synchronize the peculiarities of individual states which have also become salient in Slovakia, especially as the country strives to defend its interests in the unifying Europe and struggles with the difficulties arising from the emerging conflicts in the framework of European structures.

The formation of the political system in the previous period was marked by an arbitrary use of concepts like right, left, center, left-centrist and right-centrist parties, which even today points at some routine division of the political spectrum on the grounds of a set of automatically adopted attributes that are hardly capable of encompassing the diversity of interests and activities of the political parties. Even conflicts resulting mainly from the effort to tackle social-economic problems have been classified by ideological criteria. Meanwhile, the possibilities of individual political subjects are limited by specific conditions of the given state of the Slovak economy. This leads to a paradox – measures adopted by political parties, which despite their declaring of a different political orientation are virtually the same in terms of dealing with the reforms, gain an ideological label. However, the public's perception of the declared tactical and strategic goals is based solely on their practical, day-to-day experience.

The present research into the formation of the foreign policy of Slovakia has to a certain extent focused on the field of diplomacy and on the meetings organized at the highest level. The role of the political subjects and particular components of the political system, which are significantly involved in the transformation of the conceptual basis into strategic measures, has been neglected. With regard to political parties, the mapping of their foreign political plans has been reduced to their party programs and election promises. This results in an impression that diplomatic department is the only author of foreign political concepts.

As a result of this, we will focus our research on the analysis of domestic actors of the foreign policy, on the activities of the political parties in the parliament and their influence on the policy of the Ministry of Foreign Affairs, which is ultimately responsible for the presentation of interests of the state abroad. We will also focus on the question of how the Ministry of Foreign Affairs affects the position of political parties in the area of foreign policy, as its work is mainly based on the work of its own experts, which is in many aspects the decisive impulse for the other actors of the formation of foreign policy. In the sphere of international relations we will explore the foreign policy factors, which have influenced Slovakia's foreign policy to the largest extent. Our effort in this respect will contribute to understanding the present and future of the formation of the European political system in the framework of EU. The EU accession and the elections into the European Parliament have created new mechanisms for the resolution of minority issue in the context of bilateral

relations between the neighbouring states. These issues will be studied in the framework of the activities of individual political subjects.

In the course of our work, we will have to cope with extensive relevant domestic and foreign publications. We will base our work on theoretical material which will allow us not only to understand certain trends but also to show whether the existing theoretical conclusions are in agreement with the changing social and political conditions. Public opinion polls and printed media have proven a valuable source of information in this respect. We will also strive to get access to archived documents from the archives of the Ministry of Foreign Affairs and other central institutions.

iv. Proposed strategies and methods to be applied, and time schedule

As a border disicipline, political science often uses methods of other social sciences, which leads to its internal subdivision. Due to the sustained need to develop the Slovak philosophy of politics, political psychology, the sociology of politics, individual research into political doctrines, political institutions and processes, all this in the context of historic development, the research methods will obviously vary according to the subjects and lines of research. A series of public opinion polls - depending on the financial capacity of the institute - will probably be their organic part.

Methodological approach used in particular subjects of research will be based on the interpretation of contemporary history, which is treated very flexibly in the academic literature. In our understanding this particularly constitutes monitoring of the processes that have already unfolded and still unfold on their own basis of the formation of a democratic society and that - despite the tentative and cautious nature of efforts to delineate the completion of certain processes - exhibit certain boundedness. Such point of reference, in our treatment - with regard to the early 1990s - could be our present. Thus, the basic methodological requirement is to start from the present level of knowledge and take a chronological perspective on the events. The essence is to show the sequence of events as part of the development process, which, at the time when the events took place, could seem as a mere vision or a free, arbitrary extension of the present concepts into the future. The methodology of contemporary history does not imply the completion of an image of the immediate self-reflection in time, which would essentially be a momentary reflection on how the ongoing events are experienced. We should be aware that the contemporary history is understood as a relatively bounded developmental unit, in which the period description, the living memory and the analytical depth enabled by a time lapse overlap. Respect for these facts forces us to attempt at a developmental synthesis.

As indicated earlier, in the course of research into the role of political subjects in the development of domestic policy, factography is vital and irreplaceable. This means that what is important is not only the description of events but also their integration into the context of development and particular setting. Thus, our approach will be descriptive and analytical. Its application within the bounds of the current history requires avoiding plain descriptivism, which may lead to confusing political history with a mere reconstruction of events. At the same time, we should overcome the a priori or even speculative conceptual schemes, which usually lose track of the real events and causality. In terms f empirical and analytical approaches, the findings of sociological research, which capture the particular settings and events of the given period, have special methodological significance. In analysing the political system in question and its functioning in the real world it is necessary to use the existing knowledge base of the political science, which, however, requires differentiation between the methodology of this discipline and that of the contemporary history. On the contrary, the interpretation of the results of either of the disciplines on the basis of differences in their methodological approaches could contribute to the overall deepening of knowledge. Theoretical-methodological principles of the research into international relations will lean on the factors which might be influencing political institutions, ideas and processes in Slovakia as an external environment. In this respect, research into the formation of the political system of EU, gradual adaptation of Slovakia's policy to the policy of EU and its participation in the formation of the latter will be irreplaceable. Comparative research on the political parties, formation of their parliamentary factions in the European Parliament or the formation and functioning of the European political parties is a suitable starting point for such study and for the further development of political science in Slovakia.

The research team will focus on the analysis of the development of the world political system and reforms of the global institutions in the context of the selected global problems. Research in the area of Slovakia's security will put an emphasis on cooperation in the creation of databases encompassing major security risks such as international terrorism and the weapons of mass destruction.

Methodological approach in the international relations research should be compatible with the approaches used in gaining information on the role of political subjects in the development of foreign policy orientation. In analysing this subject memoirs and oral history of the actors and witnesses of the events unfolding in the area of foreign policy, which either had not been used, or, if at all, then only to a limited extent, will be particularly important.

The study of relations between media and politics requires the use of documents at two levels: one from the perspective of media and the other from the perspective of political parties. Monitoring of the influence of political parties and movements on the orientation of media policy should largely rely on the analysis of their positions on the situation in media

presented in the parliament or on the floor of other supreme institutions participating in the norm-setting and legislation in this area such as the Ministry of Culture. The other level is constituted by the position of media and their ambition to influence politics and public opinion. We shall analyze both the news reports and the comments in printed media — which issues they open, how they interpret and assess particular political events with a special emphasis on what they do not reflect, which, besides their effort to present themselves, may indicate a politically motivated approach of the press to individual party interests. Such analysis of respective journalist (media) genres allows us to see if media show interest in the presentation of an alternative public opinion stripped off party-political interests and if they provide impulses for a wider, non-partisan public to play its due part in making decisions on public issues. We need to analyze and encourage an opinion exchange allowing the confrontation of presentations by politicians with the opinions of political scientists. In this respect, what deserves particular attention is the analysis of findings of the public opinion polls.

In the forthcoming period we will conduct basic research in all areas mentioned above. Individual research workers will continue working on their projects, making them available to the general public both in Slovakia and abroad. Comparison of the findings gained from domestic research against the background of current international trends is a vital compotent of the research work. Thi will be ensured through the participation of our researcher workers in various academic events as well as through the organization of conferences and other events on the floor of the Institute of Political Science SAS. In the period between 2007 and 2010, we expect the publication of approximately 8—10 volumes.

- iii. Supplementary information and/or comments on responses to the scientific output of the Organisation

One of the most important demonstrations of acknowledgement of the activities of IPS SAS in all its history was the awarding of the state prize "Pribina's Cross of the 1st Degree" to the President of the Scientific Council of IPS SAS PhDr. Jozef Jablonický, DrSc. as an appreciation of his merits and dauntless civil attitudes in the struggle for the adherence to human rights and his irreplaceable position in the research on the history of the Second Czechoslovak Resistance, Slovak National Uprising and of the political persecutions of the members of resistance during the communist regime. This highest state decoration was awarded in 2006 and ceremonially presented to him on the occasion of the state holiday of the Slovak Republic on 1st January 2007.

In 2003, Jozef Jablonický received the Award of the Minister of Culture for an important contribution to the Slovak historiography.

On the floor of SAS, the IPS SAS activity in the area of popularisation of science received the "SAS Award for the popularization of science", which was confered on Miroslav Pekník and Jozef Jablonický for the yearlong radio series "The road to independence in the documents of the Slovak national identity and statehood" (2004).

The publication "MARUŠIAK, Juraj: *Slovenská literatúra a moc v druhej polovici päťdesiatych rokov*, (The Slovak literature and the power in the latter half of the 1950s) Brno: Prius 2001" won an international prize in the competition of the academies of sciences of the V4 states "The Visegrad Group Academies. Young Researchers Award 2005. Social Sciences and Humanities for Achievements in the field of Political Sciences. Wroclaw, Poland, 25th April 2005". Moreover, the above-mentioned publication won the second position in the "Competition of young research workers of SAS" (2005).

In 2006, the recognition of academic results and activities of IPS SAS found reflection in the cooperation with the supreme constitutional bodies – President's Office, Slovak Government Office, National Council of SR – which included requested participation of IPS SAS in the organization of international scientific conferences under the auspices of the Prime Minister of SR and the President of SR, expert review of the Program statement of the Slovak Government as well as collaboration on the preparation of the project "The Strategy of Development of Slovakia until 2013; The Vision for the Slovak Republic until 2030".

IPS SAS was the main coordinator of the projects "Ideological sources and currents of Slovak politics" and "Transformation of identities in the historic and present context of Slovakia with regard to the integration processes". Both received rating 4 in the final opponencies (i.e. "very good project with a very high standard")

Slovak Research and Development Agency (APVV)

On 21 July 2006, IPS SAS submitted the completed project under the general appeal of APVV "Conceptual and institutional development of the Slovak politics after 1989 and its

prospects", registration number APVV - 0039-06 (Project coordinator: PhDr. Miroslav PEKNÍK, CSc.). To this day, IPS SAS has not been delivered the resolution.

Centre of Excellence

IPS SAS, jointly with IH SAS - Project coordinator, has won the project of the Centre of Excellence of SAS ("Centre of Excellence for the Research of crucial questions of modern Slovak history", Head of the centre - PhDr. Valerián Bystrický, DrSc. Mgr. Juraj Marušiak, PhD. is in charge of the coordination of activities of the Centre of Excellence within the IPS SAS).

Participation of doctoral students in the institute's research activity

Completion of the project "Transformation of identities in the present and historic context of Slovakia with regard to the integration process" under the state program for young research and development workers "Encouragement of personality growth and talent of young research and development workers and doctoral students under 35" of the subprogram "The impelmentation of outstanding projects in support of professional growth of young researchers and doctoral students", No.: 2003 SP 51/028 09 00/028 09 12- 2003, duration: 2003- 2005 can be regarded as an achievement of IPS SAS in the area of academic training which went beyond the framework of the Institute and even SAS itself. IPS SAS worked as the coordination centre of the project. Work on the project involved both internal and external doctoral students of the Insitute and doctoral students and young researcher workers from other SAS institutes (Institute of History, Institute of Ethnology, Institute of State and Law), universities (Faculty of Social and Economic Sciences, Faculty of Philosophy of the University of Constantine the Philosopher, Nitra, University in Bratislava) and other non-academic research and development institutions (Department of media research of the Slovak Radio, Research Centre of the Slovak Foreign Policy Association, Society for Central and Eastern Europe, Matica slovenská). In 2006, the above-mentioned project received rating 4 in the final opponent reviews (very good project with a very high standard). While working on the project, an integrated multidisciplinary team of young scholars with the main focus on the issues of identities emerged. A total of 56 participants took part in the work on the project. Participation in this task has significantly contributed to the successful completion of doctoral study of 9 project team members by defending their theses and gaining a PhD-degree.

Participation in the educational work abroad

On annual basis, IPS SAS takes active part in the academic training abroad. Following the framework agreement on cooperation with the Department of history and civic education of the Faculty of Education, Technical University, Liberec (Czech Republic) it coordinated the XVI annual seminar for teachers of history and civic education, historians and archivists both from Slovakia and from the Czech Republic "The Czech-Slovak realations/ the Slovak-Czech relations" on 24-25 August 2006. The subject of this year's event was "The World and Czechoslovakia from crisis to crisis (October 1956- October 1962) – the Czechs and the

Slovaks in a period of the Cold War." The Department receives all book outputs produced by IPS SAS.

Doctoral study - problems with inadequate staffing

Over the period of 2003-2006, the situation around the doctoral study on the Theory of Politics was difficult; only two institutes - the Facluty of Political Science and International Realtions, UMB Banská Bystrica, and the department of Political Science, FF UU, Bratislava, were entitled to supervise and conduct doctoral defences in the field. As a result, there were increasing numbers of students applying for PhD studies at the institute, which put a strain on the insitute's academic workers. To cope with this uneasy situation, an "Agreement on a future agreement" was signed between the Faculty of Philosophy, CU, Bratislava, and the IPS SAS, Bratislava, on the cooperation in the preparation and organization of doctoral studies on 29 April 2004. Owing to the high number of doctoral students, who are supposed to complete their studies by the end of 2010, by late 2004 we decided to stop admitting further applicants in the immediate future.

The case of an external PhD.- student of IPS SAS PhDr. Róbert Ondrejcsák

In 2005, the IPS SAS found itself in an unsual position with regard to PhD-study. Following a successful defence of two of our external PhD students - Mgr Ľuboš Kubina and PhDr.Róbert Ondrejcsák, a precedent was created when the Academic Council of the FA CU in Bratislava did not grant a PhD degree to PhDr.R.Ondrejcsák. Letter of doc.PhDr.Anton Eliáš PhD,, Dean of the Faculty of Philosophy CU - No. VED 6661/2005 of November 2 2005 to PhDr.Róbert Ondrejcsák reads as follows: "For approval of a proposal to grant academic degree "philosophiae doctor" in accordance with the Internal Order of the Faculty of Arts CU in Bratislava, Article 3 Section 7 an approval of the majority of over 50% all members of the council is required. During the voting on the proposal to grant academic degree "philosophiae doctor", the Academic Council of the Faculty of Philosophy CU in Bratislava expessed its position in the following way: the Academic Council of FP CU has 32 memebers, of the 23 presented during the voting procedure, 15 voted for, 4 voted against. 4 votes were not valid. As a reuslt, the Academic Council of FP CU did not approve the proposal to grant an academic degree "philosophiae doctor"."

Since, in the view of IPS SAS, the doctoral study of PhDr,. Róbert Ondrejcsák was completed successfully, we asked in Letter No.323/2005 of November 11 2005 the Rector of Comenius University for the clarification, as the relevant piece of legislation does not take such possibility into account.. Moreover, the Faculty of Political Science and International Relations UMB had not used its right to conduct doctoral defences in the field of "Theory of

Politics". In Letter No.197/2005/OL of December 20 2005, Vice-Rector of CU JUDr.Mária Duračínská CSc. informed us that "the Rector will investigate our appeal". In Letter No. 48/2006/OL of February 3 2006, Rector of CU doc.PhDr.František Gáher PhD. sent a reply both to PhDr. Róbert Ondrecsák and the IPS SAS that: "within the scope of authority of the self-governing body it is not possible to act beyond the legal norms and the decision not to grant an academic degree is to be respected"

The case of Mgr Pavol Lukáč, external PhD student of IPS SAS

In 2006, VEDA – the Publishing House of SAS, issued an unfinished thesis of untimely deceased PhD-student Pavol Lukač under the title "Milan Hodža in the struggle for future of Central Europe in 1939-44" prepared for publication by Dr.Štefan Šebesta and Prof.PhDr.Pavol Petruf DrSc. Subsequently, the Director of the IPS SAS addressed doc.PhDr.František Gahér PhD, Rector of Comenius University, requesting to grant Pavol Lukáč an academic degree PhD in memoriam (Letter of Director of IPS SAS No.285/2006 of October 26 2006). However, talks with doc. PhDr. Anton Eliáš CSc, Dean of the Faculty of Philosophy CU and Vice-Dean for science doc.PhDr.Ladislav Kiczko CSc were not succesful as the relevant piece of legislation does not allow for such a move (not even the granting a PhDr. degree). Thus, it is within the autohirity of the Rector of CU to decide whether he will create such precedent "via facti".

6. Direct output to the society (applications of results, popularisation and outreach activities)

Cooperation of the IPS SAS with the decision-making bodies

The work on the projects of the state program "Conceptual sources and lines of the Slovak politics" has, since their launch in 2003, aroused active interest of the decision-making bodies in the results of the academic activity of IPS SAS. The institute was successively addressed by the Office of the President of SR, the National Council of SR, the Slovak Government Office, the Ministry of Foreign Affairs of SR, the Ministry of Defense of SR and the Ministry of Culture of SR. This cooperation was enhanced by the fact that some research workers of the above-mentioned institutions directly participated in the work on the

project "Conceptual sources and lines of the Slovak politics" of the state research and development program "Participation of humanities in the development of society" including Miroslav Mojžita (Foreign Ministry), Urban Rusnák (Foreign Ministry), Viliam Roth (President's Office), Milan Ježovica (Government Office). Further representatives of the younger generation working in the decision-making institutions were admitted to doctoral study in the IP SAS.

The cooperation assumed various forms – expert activity, provision of selected results from academic research, provision of requested book publications produced by the institute, participation in the work sessions of the state administration bodies including reception with the President of the Republic, the President of the Slovak National Council and the Prime Minister.

Cooperation with the Ministry of Foreign Affairs of SR and Ministry of Defense of SR

Minister of Foreign Affairs of SR Eduard Kukan officially asked the Director of the IPS SAS by Letter No.201.975/2004 - KAMI of September 9, 2004, for "the provision of selected research results to meet the needs of the officials of the Ministry of Foreign Affairs"; these results were part of the outcome of the project "Conceptual sources and lines of the Slovak politics", which "has also been joined by some of the Ministry staff." At the same time, in his letter, Minister Kukan wrote as follows: "I believe ... that such policy will constitute a further contribution to the implementation of the agreement on mutual cooperation and support between the Ministry of Foreign Affairs of the Slovak Republic and the Slovak Academy of Sciences of November 2000."

On this request, IPS SAS submitted to the Slovak Foreign Ministry selected results of the sociological research into public opinion (June, October 2004) conducted jointly with the Media Research Department of the Slovak Radio. The materials included:

- Citizens' opinions on selected EU issues (183 p.)
- Public's opinions on selected EU issues and cross-border cooperation I.-II. (501p.)

Mutual contacts are documented by correspondence between the Director of IPS SAS and the Slovak Foreign Minister (Letter by the Director of IPS SAS No. 342/2004 of 5 October 2004; Letter of Gratitude by Minister Kukan (Letter No. 202.233/2004-KAMI of 15 October 2004; Letter by the Director of IPS SAS No. 424/2004 of 13 December 2004).

Further lines of cooperation between IPS SAS and the Slovak Foreign Ministry included the compilation and publication of a book by Miroslav Mojžita entitled "Formation

of the Slovak Diplomacy in 1990-1993. Kňažko – Demeš - Kňažko" as part of the project "Conceptual sources and lines of the Slovak politics".

The book presentation and the academic symposium on this subject were held on 20 December 2004 at the Slovak Foreign Ministry with the participation of Minister Eduard Kukan, the former ministers Milan Kňažko and Pavol Demeš, numerous experts, current and former ambassadors and other diplomats. This was a prestigious event not only for IPS SAS but also for the Slovak Foreign Ministry and became an expression of the agreement between the Slovak Foreign Ministry and SAS. The symposium was moderated by PhDr. Milan Zemko CSc., member of the Presidium SAS.

In the course of events, the Institute of Political Science moved in advance to the application stage of the research results of the project "Conceptual sources and lines of the Slovak politics" in political practice when the Slovak Foreign Ministry requested 250 copies of this publication for its internal needs. Thus, investment of the financial resources in the research proved fruitful (Letter of the Slovak Foreign Ministry No. 100.504/2004; ARDO/162 of 6 December 2004; Letter of the Director of IPS SAS No. 423/2004 of 13 December 2004; Letter of the Slovak Foreign Ministry – unnumbered/2005-ARDO of 20 January 2005; Letter of the Director of IPS SAS No. 56/2005 of 22 February 2005).

In the last days of 2004, the Slovak Foreign Ministry provided financial resources in the amount of SKK 466 300 for the publication of a book by Šebesta Štefan (ed.): "Partnerstvo pre bezpečnosť a rozvoj. Dokumenty NATO z rokov 2002 – 2004" (Partnership for security and development. NATO Documents from the period of 2002 - 2004), Volume III of the edition of IPS SAS (Letter by the Director of IPS SAS No. 407/2004 of 2 December 2004; agreement between the Slovak Foreign Ministry and the VEDA Publishing House).

The Slovak Defense Ministry participated in the preparation of the book by providing its expertise. This is confirmed by the forewords of the ministers of both departments (Letter of the Director of IPS SAS No. 322/2005 of 3 November 2005). Dr. Štefan Šebesta, author of the book, worked as a member of the Board of External Advisors to the Foreign Minister.

In this context, it is necessary to mention that on 28 November 2005, Mgr. Juraj Marušiak, PhD., research worker of IPS SAS, took part in the round-table meeting at the Ministry of Foreign Affairs of SR with the participation of representatives of the diplomatic corps and non-governmental organizations as well as deputies of the National Council of SR summoned by Minister E. Kukan and State Secretary M. Vášáryová. The subject of the talks was conceptual framework of the policy of the Slovak Republic towards Belarus in the context of the upcoming presidential elections in the country in March 2006.

Research worker of the Institute Mgr. Juraj Marušiak, PhD. took part in the electoral observer missions organized by the Ministry of Foreign Affiairs of the Slovak Republic in the framework of the OSCE missions and missions organized by the NGO's financed by the Ministry of Foreign Affairs on the presidential elections in Ukraine (November 2004), Belarus (March 2006) and on the parliamentary elections in Ukraine (March 2006).

Particular interest in the implementation of results achieved by IPS SAS on the part of the Slovak Foreign Ministry and the Ministry of Defense is exemplified by a monograph "Geopolitics of the Central European Region. The view from Prague and Bratislava" by Oskar Krejčí published by IPS SAS late in September 2005 in VEDA, Publishing House of the SAS. Officials of both departments requested IPS SAS to provide a number of copies for the internal needs of both ministries. The Ministry of Defense received 100 copies (Letter of the Ministry of Defense of SR, Č. p.: seŠT-2-96/2005 of 18 November 2005; Letter of IPS SAS No. 342/2005 of 30 November 2005). With regard to the Slovak Foreign Ministry, interest was shown first by embassies in Syria, Ukraine, Indonesia, Serbia and Monte Negro and Austria. Subsequently, Slovak Foreign Minister E. Kukan requested another 100 copies of the publication as, in his words, "it will find everyday application as an information source both in the Slovak Ministry and in our diplomatic missions and Slovak institutions abroad" (Letter No. 201.498/2005-KAMI of 12 October 2005; Letter of the Director of IPS SAS No. 341/2005 of 30 November 2005).

The above-mentioned letter of 30 November 2005 by the Director of IPS SAS informed Foreign Minister E. Kukan that the Publishing House of SAS would soon issue a collective monograph Benkovič B., Krejčí O., Pekník M., Žárska, E.: "Verejná mienka a politika. Medzinárodné vzťahy a zahraničná politika Slovenskej Republiky (Public opinion and politics. International relations and international policy of the Slovak Republic) ", which did materialize. The monograph includes elaborated results of sociological research into public opinion, a preliminary copy of which we presented to the Slovak Foreign Ministry in advance, in 2004.

2. Cooperation with the Slovak Government Office

In 2004, IPS SAS followed on from the previous cooperation with the Slovak Government Office in 2002, when on the occasion of transport of the remains of Milan Hodža from the U.S.A to Slovakia and their burial in the National Cemetery in Martin on 27 June 2002 our book publication Pekník, M. a kolektív: Milan Hodža – štátnik a politik (Milan Hodža – statesman and politician) was presented at Turiec Hotel to tie in with the event. The book was issued with the financial contribution of the Slovak Government Office (Accreditation Report of the IPS SAS for 2002-2003, p. 13).

In this context, on the initiative of Slovak Prime Minister Mikuláš Dzurinda in summer 2004 a more broadly conceived project "Milan Hodža days in Martin" was launched, which was intended to promote and develop the conceptual heritage of M. Hodža both in Central European and in broader European context. By 2004, several meetings were held to that effect (Annual Activity Report of the IPS SAS for 2004, pp. 23-24). As a result, in the following year on 23 – 26 June 2005 under the auspices of Slovak Prime Minister Mikuláš Dzurinda a large-scale event was held under the title "Milan Hodža Days 2005" in Martin. The Slovak Academy of Sciences, particularly IPS SAS and later also the Institute of History SAS played a substantial part in the preparation and materialization of the event.

"Milan Hodža Days in Martin 2005" were co-organized by the Slovak Government Office, the Slovak Academy of Sciences, the Slovak National Library in Martin, the Slovak Society for Foreign Policy, the town of Martin, the Slovak Chamber Theatre in Martin, the Board of National Culture, the village of Sučany, Milan Hodža Secondary School at Sučany. Since early that year, we participated in several meetings in Martin and Bratislava to ensure detailed preparation of the event.

Within the adopted conceptual framework, IPS SAS became the guarantor of the international academic conference "Milan Hodža and the integration of central Europe", committing itself to working out the future schedule of Hodža events in Martin with a time horizon until 2010. The institute also committed itself to becoming a consultant on the selection of themes for the countrywide secondary students competition "Hodža's Essay", finding a jury, selecting the winners, and, additionally, to compiling expert comments on the theatre performance Hodža: Grandseňor v halene (Hodža: Grand signor in a peasant smock) ", which was premiered in Martin as part of the event and which has been in the repertoire of the Slovak Chamber Theatre in Martin since autumn 2005.

IPS SAS has also participated in the media presentation of the event. Beyond the planned promotion of the event, the institute has organized the presentations of IPS SAS research workers (M. Pekník, M. Hronský) and Milan Hodža's grandson John Palka in the Slovak Radio ("Contact Studio" of 17 June 2005 and "At first hand" of 27 June 2005, reporter Lýdia Mrázová).

To enhance media presentation of the Slovak Academy of Sciences in the official information and promotion campaign organized by the Government Office, we decided to present SAS as a whole; IPS SAS and the Institute of History SAS were mentioned independently only during the international academic conference "Milan Hodža and the integration of Central Europe". The significant position of the Slovak Academy of Sciences among the organizers of Milan Hodža Days was emphasized by the protocol of the Slovak

Government Office, when the President of the Slovak Academy of Sciences was listed immediately after Prime Minister M. Dzurinda.

In creating the conceptual framework, we took into account the intention of the Slovak Government Office to organize Milan Hodža Days on a regular basis. To that effect we avoided a comprehensive presentation of Milan Hodža's activities and prepared a series of individual topics with regard for the future presentations. The conference was built around the presentations of the SAS research workers. IPS SAS was represented by Dr. Miroslav Pekník, Dr. Marián Hronský, Dr. Jozef Kiss and Dr. Štefan Šebesta, who, jointly with the research workers of the Institute of History SAS, provided the backbone of the selected subject. They offered a vivid pictue of the development of Hodža's views on the integration of Central Europe before WWI and in the interwar period, when Hodža became a renowned politician and statesman, and, finally, of their eventuation into his political heritage — a book "Federation in Central Europe" and a memorandum on the post-war policy of the Allies in Central Europe.

It may be stated that the international conference "Milan Hodža and the integration of Central Europe" was not an ordinary academic event. Along with the strengthening of national and state traditions, it has contributed to a growing interest of the highest state officials in the study and popularization of life and work of outstanding personalities of the Slovak political life in the past. The political heritage of Milan Hodža and on the other hand also of Alexander Dubček, as well as of other personalities, their views, plans and conceptions have reverberated in the minds of contemporary statesmen and politicians and may also serve as inspiration for the formation of the Slovak politics in the future.

The Slovak Academy of Sciences and its institutes have in this respect achieved solid results, which have been presented abroad. This was acknowledged and emphasised, in the presence of President of SAS prof. Ing. Štefan Luby, DrSc. and the participants of the international academic conference "Milan Hodža and the integration of Central Europe" in Martin, by Slovak Prime Minister Mikuláš Dzurinda in his opening speech. He expressed his gratitude for the organization of the conference with a wish that the conference proceedings would soon get in the hands of the public and the event would be held in the following year. This appreciation and wish was also expressed in a personal letter to the Director of IPS SAS of 8 July 2005.

At the request of Director of the Prime Minister's Office Mgr. Viktória Jančošeková in a letter of 5 May 2006, the institute provided selected book publications from the academic production of IPS SAS and from research work on the projects of state research and development program "Conceptual sources and lines of the Slovak politics" and "Transition

of identities in the contemporary and historical context of Slovakia with the main focus on the processes of integration" for the internal needs of Slovak Prime Minister M. Dzurinda and for practical applications (Letter of the Director of IPS SAS, No. 121/2006 of 19 May 2006).

Milan Hodža Days were also organized in 2006, again under the auspices of Prime Minister Mikuláš Dzurinda. The event began on Thursday, 22 June 2006 by a commemorative act at Milan Hodža's grave in the National cemetery in Martin. Slovak Prime Minister Mikuláš Dzurinda, members of Milan Hodža's family, Mayor of Martin Stanislav Bernát, mayor of the town of Sučany Milan Rybár, citizens of Martin and other honorary guests took part in the event.

At an afternoon meeting with youth at the Theatre Square, the Prime Minister awarded the Prize of Milan Hodža to Ján Langoš in memoriam, for his political activity and meritorious work in the preservation of documents of the Institute of National Memory.

On 23 June 2006, at the academic conference in the auditorium of the Slovak National Library at Hostihora a number of presentations were delivered under the title "Milan Hodža - politician and journalist". The audience included experts and admirers of Milan Hodža, students from Martin secondary schools and other participants. The conference was opened by doc. PhDr. Dušan Katuščák, CSc., General Director of the Slovak National Library and Milan Hodža's grandson, prof. John Palka from the U.S.A. The expert guarantor of the academic conference was IPS SAS. Presentations were delivered by PhDr. Miroslav Pekník, CSc., PhDr. Marián Hronský, DrSc., Dr. Jozef Kiss, CSc., and Mgr. Norbert Kmeť, CSc. The overall number of presenters both from Slovakia and from the Czech Republic was 14. The proceedings from the conference will be available next year.

During the Martin celebrations, two books on Milan Hodža issued by IPS SAS in 2006 were presented. They included a collection of studies form the 2005 conference edited by M. Pekník under the title "Milan Hodža and the integration of Central Europe", which was introduced at the conference. An unfinished doctoral thesis by Pavol Lukáč, a prematurely deceased doctoral student of IPS SAS, entitled "Milan Hodža in the struggle for the future of Central Europe in 1939 – 1944" was edited and prepared for publication by JUDr. Štefan Šebesta and prof. PhDr. Pavol Petruf, DrSc. The book was introduced by Rudolf Chmel, then Minister of Culture and author of the foreword at the Theatre square.

The selection of winners of the essay competition took place at Sučany at the presence of State Secretary of the Slovak Foreign Ministry Magda Vášáryová and Milan Hodža's grandson – John Palka. The motto of the essays was Hodža's quotation from the Slovak Weekly of 1903: "If we Slovaks are to become anything, we cannot rely on anyone or anything else but our own work and our common sense". This served as a stimulus for the students to think about their own future and success. Entries were sent by 19 secondary school students from all over the country.

The continuing project along with the prepared conceptual framework for the period until 2010 is an essential condition for the regular holding of the event. Establishment of the tradition where the Slovak Prime Minister shares the heritage of Milan Hodža – the first Slovak Prime Minister in the Czechoslovak government, is a worthy tribute of this outstanding politician and statesman.

*

Following the parliamentary elections, in the latter half of 2006 cooperation with the Slovak Government Office (Slovak Prime Minister's Office; Slovak Prime Minister's Advisory Board) continued in multiple directions.

On 7 July 2006, during a meeting of the Director of IPS SAS and L'. Benkovičová with Deputy Prime Minister Dušan Čaplovič, IPS SAS was requested to provide book publications from the production of IPS SAS and research work on the projects of state research and development program "Conceptual sources and lines of the Slovak politics" and "Transition of identities in the contemporary and historical context of Slovakia with the main focus on the processes of integration" (Letter of the Director of IPS SAS, No. 182/2006 of 10 July 2006). IPS SAS was also asked to conduct expert studies on the Program Statement of the Slovak Government. The following institute's research workers participated: L'. Benkovičová, L'. Blaha, M. Hronský, E. Jaššová, N. Kmeť, J. Kiss, O. Krejčí, J. Marušiak, M. Pekník, D. Šmihula along with close cooperators of IPS SAS (Letter of Slovak Prime Minister Róbert Fico of 28 July 2006; Letter of Director of IPS SAS No. 203/2006 of 31 July 2006). Subsequently, on 2 August 2006 a meeting was held in the National Council of SR between the Slovak Prime Minister and IPS SAS research workers (Krejčí, M. Pekník), when the Prime Minister expressed his gratitude for the studies.

Further cooperation with the Slovak Government Office and the Prime Minister's Office in particular was specified after the meeting of Chairman of the Slovak Prime Minister's Advisory Board Dr. V. Faič with the Director of IPS SAS. The Chairman of the Slovak Prime Minister's Advisory Board welcomed the material "Proposal for the cooperation between IPS SAS and the Slovak Prime Minister's Office", which was to some extent similar to the agreement on cooperation with the Office of the President of the Slovak Republic (Letter of the Director of IPS SAS No. 211/2006 of 10 August 2006).

Within the agreed cooperation, the Prime Minister's Office was presented with book publications for the internal need of the Prime Minister and the Advisory Board (Letter by the Director of IPS SAS No. 234/2006 of 5 September 2006 and No. 255/2006 of 3 October 2006).

IPS SAS was, along with the Institute of Economic Research SAS (main guarantor) and the Institute for Forecasting SAS, called to prepare and complete the project "The strategy of development of Slovakia until 2013. The vision for Slovakia until 2030", adopted

by the Government of SR. In this context, several meetings were held between August and December at which ideas about the conceptual framework and research team crystallized (on 28 August 2006; on 5 September 2006; on 12 September 2006; minutes of 13 November 2006; minutes of 14 December 2006). The government was represented by the Chairman of the Advisory Board and the Minister of Economy.

On the initiative of the President of SAS at the meeting of directors of Section III SAS on 27 September 2006 on the improvement of contacts with the decision-making bodies and support of the basic research in SAS form the state organs, cooperation between IPS SAS and the Slovak Prime Minister's Office through the Advisory Board acquired a new dimension, which was not directly linked with the work of the institute. Based on the talks between the Director of IPS SAS and Chairman of the Advisory Board V. Faič a proposal was submitted for the establishment of the Centre of molecular medicine. The authors of the proposal were prof. RNDr. Jaromír Pastorek, DrSc. and Ing. Albert Breier, DrSc., directors of the Institute of Virology SAS a Institute of Molecular Physiology a Genetics SAS. The accompanying letter to the material stated: "Owing to the fact that both these institutes are renowned and recognized abroad, their proposal may be regarded as an unofficial "model" and one of the possibilities of how to proceed in the following period in the area of support for the basic research in SAS while at the same time placing emphasis - on the part of the Slovak Government – on the application of the research results for the benefit of the state" (Letter of Director of IPS SAS No. 254/2006 of 3 October 2006 and No. 344/2006 of 21 December 2006).

Cooperation with the Slovak Government Office has gained a significant academic dimension through the organization of the international academic conference "Alexander Dubček – outstanding Slovak a European" held on 24–25 November 2006 in Bratislava and Trenčín under the auspices of Slovak Prime Minister Róbert Fico as part of the Memorial Days of Alexander Dubček.

3. Cooperation with the Office of the President of the Slovak Republic

Based on the results of our sociological public opinion research within the project "Conceptual sources and lines of the Slovak politics" of the state research and development program "The role of social sciences in the development of society", from early 2004 our contact with the Slovak President's Office was rather frequent. Due to the political situation – referendum, presidential elections and Roma unrest - the Director of IPS SAS and other research workers were repeatedly summoned to the meetings in the office of then President R. Schuster (official invitation for the Director of IPS SAS of 26 January 2004; No. 1220/2004 BA of 18 February 2004 and e-mail of the SAS President).

Newly elected President of the Slovak Republic Ivan Gašparovič equally showed interest in the academic work of our insitute. On 14 July 2004, Director of IPS SAS was visited by Director of the Secretariat of the President of SR Dr. Marián Parkányi. The subject of talks was potential cooperation and the application of results of the institute's academic research for the internal use of the Slovak President's Office. To this effect, talks were held between Head of the Office of the President of the Slovak Republic Milan Čič and the Director of IPS SAS on 2 August 2004 in Bratislava and on 29 August 2004 in Banská Bystrica. As a result, we worked out a "Proposal of IPS SAS for cooperation with the Office of the President of the Slovak Republic". (Letter by the Director of IPS SAS No. 320/2004 of 10 September 2004). In the proposal we laid out our ideas and real possibilities of cooperation while emphasizing that "the centre of our cooperation with the Office of the President of the Slovak Republic would... – owing to the profile of IPS SAS – unambiguously be the provision of selected academic results gained from the completed or running research projects. As for the so-called operational cooperation, this is, given the low staffing level of IPS SAS, impossible, and if at all, then only sporadically." The proposal was accepted by the Slovak President's Office and cooperation in 2004 took place in the following manner.

- **1.** Based on further talks and official requests of Director of the President's Secretariat Dr. Marián Parkány (Letters of 3 September 2004, of 4 October 2004 and 1December 2004) we provided selected research results of IPS SAS for the internal use of President of the Slovak Republic Ivan Gašparovič:
- a) Within the project "Conceptual sources and a lines of the Slovak politics" of the state reserach and development program "The role of social sciences in the development of society" material was compiled from the sociological research into public opinion conducted in cooperation with the media research department of the Slovak radio:
 - The image of President of the Slovak Republic Ivan Gašparovič (191 p.);
 - Citizens' views on the selected EU issues (183 p.);
 - Public's views on the selected issues of the European Union and cross-boarder cooperation I. – II. (501 p.).
- b) Within the project "Transition of identities in the contemporary and historical context of Slovakia with the main focus on the integration processes" and the subprogram "The implementation of outstanding projects in support of the professional growth of young research and development workers and doctoral students", of the state research and development program "Encouragement of personality growth and talent of young research and development workers and doctoral students under 35":
- Benkovič Boris: "The image of Roma in the selected Slovak media" doctoral thesis, defended in September 2004;

- c) Book publications form the production of IPS SAS (22 titles) within the above-mentioned "IPS SAS proposal for cooperation with the Office of the President of the Slovak Republic." (Letters from the Director of IPS SAS to the President of the SR No. 316/2004 of 6 September 2004; No. 343/2004 of 6 October 2004; No. 411/2004 of 3 December 2004).
- 2. Even though the Proposal for Cooperation with the President's office did not include operational cooperation, on the telephone request of the President of SAS prof. Ing. Štefan Luby, DrSc., on 15 October 2004, when the SAS President promised to solve problems with the provision of the salary fund for IPS SAS for the approved limit of workers early in 2005, we reversed our decision. IPS SAS carried out evaluation of conceptual materials on the work of the President of SR. Their opponency took place on 22 November 2004 at the meeting in the President's Office (Letter of Head of the President's Office Acad. Milan Čič No. 4969/2004 BA of 12 November 2004; Letter of the Director of IPS SAS No. 432/2004 of 24 November 2004). The meeting concluded that IPS SAS would participate in further work in accordance with the requests of the Office of the President of SR ((Letter No. 4969/2004 BA of 3 December 2004). Thus, we extended our cooperation to the area despite the insufficient staff, which we had pointed out earlier.

Our effort was also appreciated by the President of the Republic himself. He expressed his gratitude both for the provided materials and for the cooperation with the President's Office personally to the Director of IPS SAS at a meeting in the President's Palace at the office of the Director of the Secretariat of the President of the Slovak Republic on 4 January 2005.

*

Cooperation with the Office of the President of the Republic continued on a systematic basis also in 2005. In a practical form, it developed officially through the Director of IPS SAS in the following manner:

- 1. On the basis of discussions and written requests of Director of the Secretariat of the President of the Republic Dr Marián Parkányi, President of the Republic Ivan Gašparovič was supplied with the materials produced within the project "Conceptual sources and lines of the Slovak politics" of state research and development program "The role of social sciences in the development of society" as well as with the results of other academic research work of IPS SAS. They particularly included selected results from sociological research into public opinion conducted jointly with the Media research Department of the Slovak Radio, academic studies and requested expert materials.
- Based on the discussion with the Director of the Secretariat of the President of the Slovak Republic, on 4 January 2005 a material was sent under the title "Proposal for the

scope of the small round-table discussions on international issues" (Letter of the Director of IPS SAS No. 15/2005 of 14 January 2005),

- Public's opinion on the current issues of the internal and international policy" (requested by the letter of Director of the Secretariat Dr. M. Parkányi of 10 January 2005 and supplied with the accompanying letter of the Director of IPS SAS No. 22/2005 of 21January 2005),
- materials for the small round-table discussion on international issues at the office of the President of the Slovak Republic in connection with the preparation of the Bush-Putin summit in Bratislava (requested by the letter of Director of the Secretariat Dr. M. Parkányi of 25 January 2005 and supplied with the accompanying letters of the Director of IPS SAS No. 31/2005 of 1 February 2005, No. 41/2005 of 10 February 2005),
- "General public on the current issues of the interior policy" (Letter of the Director of IPS SAS No. 80/2005 of 18 March 2005),
- "Citizens' views on the selected EU issues" (Letter of the Director of IPS SAS No. 80/2005 of 18 March 2005),
- "Public's physical activity, sports and country representation in the program objectives of the President of the Slovak Republic" (Letter of the Director of IPS SAS No. 97/2005 of 7 April 2005),
- "Development of the system of mass communication in Slovakia" (Letter of the Director of IPS SAS No. 113/2005 of 19 April 2005),
- "The Slovak Radio through the eyes of the public" (Letter of the Director of IPS SAS No. 113/2005 of 19 April 2005),
- "Communication of the representatives of political and public life on the Slovak Radio waves in the program "The Night Dialogues" (Letter of the Director of IPS SAS No. 113/2005 of 19 April 2005),
- "International security and politics" (Letter of the Director of IPS SAS No. 130/2005 of 5 May 2005),
- "Views on the issues of foreign and security policy" (requested by the letter of Director of the Secretariat Dr. M. Parkányi of 21 November 2005, letter of the Director of IPS SAS No. 337/2005 of 29 November 2005),
- "Citizens on the development of the Slovak society in the next decade I-II" (requested by the letter of Director of the Secretariat Dr. M. Parkányi of 21 November 2005, letter of the Director of IPS SAS No. 337/2005 of 29 November 2005),
- "Views on the principles and methods of the naming of new streets, buildings, squares, bridges etc" (requested by the letter of Director of the Secretariat Dr. M.

Parkányi of 21 November 2005, letter of the Director of IPS SAS No. 337/2005 of 29 November 2005),

- "Political horizons of the Slovak Republic until 2015, version I" (requested by the letter of Director of the Secretariat Dr. M. Parkányi of 21 November 2005, letter of the Director of IPS SAS No. 337/2005 of 29 November 2005),
- Vision of the development of physical activity and sports performed by the Slovak population (revised and completed material from 7 April 2005) (requested by the letter of Director of the Secretariat Dr. M. Parkányi of 14 December 2005, letter of the Director of IPS SAS No. 362/2005 of 16 December 2005),
- "The roots of militant Islam in the Near East" (requested by the letter of Director of the Secretariat Dr. M. Parkányi of 14 December 2005, letter of the Director of IPS SAS No. 362/2005 of 16 December 2005).

In addition to the materials mentioned above, IPS SAS also supplied the latest publications from the production of the institute in 2005.

Small round-table meetings presented a special form of cooperation. With regard to the prepared summit of the presidents of the USA and the Russian Federation in Bratislava, IPS SAS was requested to prepare and write background materials for a small round-table meeting with president of the Slovak Republic Ivan Gašparovič held on 9 February 2005; the focus of the discussion was "Current issues in the international relations and the foreign policy of the Slovak Republic."

IPS SAS was represented by prof. PhDr. Oskar Krejčí, CSc. and the director of the institute. As a result of the 90-minute meeting, President Ivan Gašparovič expressed a request that further small round-table meetings were held in a similar form with the focus on current political issues (invitation of 2 February 2005; informing letter of the Director of IPS SAS sent to the SAS President No. 45/2005 of 15 February 2005).

The next round-table meeting with the President of the Republic was held on 13 April 2005. The subject of the discussion was selected results of the sociological research into public opinion gained during the work on the project "Conceptual sources and lines of the Slovak politics" of the state research and development program "The role of social sciences in the development of society". They referred to the relations between politics and mass media, their statutory nature as well as other issues of the interior and foreign policy of the Slovak Republic. Since the research was conducted jointly with the Slovak Radio Media Reserach Department, the meeting was participated – besides the Director of IPS SAS – by research workers in the relevant area - PhDr. Ivan Sečík, CSc. a PhDr. L'udmila Benkovičová, CSc., who reported on the issue. At the end of the meeting, President Ivan Gašparovič spoke favorably of the presented materials and appreciated the existing cooperation with the SAS (informing letter of the Director of IPS SAS to the SAS President

No. 104/2005 of 15 April 2005). He expressed his satisfaction with the cooperation in a personal letter to the director of the institute, in which he appreciated the contribution of IPS SAS to the development of political science in Slovakia (24 November 2005).

With regard to the above-mentioned activities of IPS SAS, we asked President of the Slovak Republic Ivan Gašparovič to accept our request for his patronage of the international academic conference "MUDr. Vavro Šrobár – politician, journalist and educationalist" held on 25-26 October 2005 on the floor of Comenius University, which he did (Letter of the Director of IPS SAS No. 220/2005 of 19 July 2005; Letter of the President's Office No. 4248-2005-BA z 3.8.2005).

2. Already at the beginning of our work contacts with the Office of the President of the Slovak Republic, we stated in the material "IPS SAS proposal for the cooperation with the Office of the President of the SR" the following: As for the so-called operational cooperation, this is, given the low staffing level of IPS SAS, impossible, and if at all, then only sporadically." As already mentioned, on the telephone request of President of SAS prof. Ing. Štefan Luby, DrSc., on 15 October 2004 – in the interests of the prestige of SAS – we were more obliging to the demands of the Office of the President of the Slovak Republic in this respect (Report on the work of IPS SAS for 2004, p. 25). It must be stated however that in the following period, in 2005, this was not very easy and the material in question had to be processed by the Director of IPS SAS himself.

In 2005, IPS SAS followed on from the previous work on the evaluation of the conceptual materials on the work of the President of the Slovak Republic. On the request of Head of the office of the President of the Slovak Republic prof. JUDr. Milan Čič, DrSc. and Director of the Department of Interior Policy Ing. Boris Sopira, we processed and submitted further background materials, which included:

- Conceptions of the solution of the Slovak issue before WWI.
- Lines of the Slovak politics in 1914-1920.
- Ideological currents and political parties in 1945-1948.
- Lines of the Slovak politics of the 1960s in the present context.
- Changes after 1989 and their acceptance in the society.
- From state paternalism to one's own accountability.
- The governance of political parties at the expense of professionalism in the control of state and public affairs.
- Authority and credibility of the executive power and parliament, respect in the relations between three highest political representatives.
- Ethnic identity from the perspective of ethnology.
- National identity, national and cultural traditions.
- The paradoxes of our time.

- A change of the lifestyle of the population with all the positives and negatives
- Development, state and prospects of education system in the Slovak Republic
- The development of modern social state.

(Letter of acad. M. Čič No. .4969/2004-BA of 12 November 2004; Letter of Ing. Sopira No.. 4969/2004-BA of 3December 2004; and accompanying letters of the director of IPS SAS to the submitted materials No.. 52/2005 of 17 February 2005; No. 72/2005 of 3 March 2005; No. 76/2005 of 9 March 2005).

In connection with the preparation of the "Report on the state of the republic", IPS SAS was officially requested to analyze the notes and comments on the proposed text. In addition to internal staff, the task was undertaken by several external research workers of IPS SAS. The director of the institute and prof. Oskar Krejčí accepted the invitation to express their opinions on the presented Report on the State of the Republic immediately after the address of the president of the Slovak Republic in the National Council of the Slovak Republic on 22 June 2005 in a live Slovak Radio broadcast (accompanying letter of the Director of IPS SAS No. 156/2005 of 26 May 2005 – Position and comments concerning the material "Report on the State of the Republic", radio program "At first hand", moderator Lýdia Mrázová).

On 19 – 20 September 2005, at the working discussion at Modra – Harmónia organized by Head of the Office of the President of the Republic prof. JUDr. Milan Čič, DrSc. - to the effect of his letter No. 38 28/2005-BA of 15July 2005 – the subject of discussion was sustained cooperation on studies extended by further topics, on which IPS SAS had worked in the previous period. This cooperation with the Office of the President of the Republic, supplemented with the requested book production of IPS SAS, continued until early December 2005. Owing to the fact that, by that time, despite our requests, the promise of the president of SAS to provide financial resources for the salary fund (tariff salaries) in the required amount had not been fulfilled, we were forced to downsize the number of research staff. Therefore, the director of the institute was forced to inform Head of the Office of President of SR prof. JUDr. Milan Čič DrSc. in a Letter No. 350/2005 of 8 December 2005 that "as a result of downsizing, the current personnel size of the IPS SAS is insufficient to complete the required volume of work. At the same time, we stated in the letter that "nevertheless, we will strive to sustain the working contacts with the Secretariat of the President of the SR related to Mr President's needs." The letter was sent to the information of the President of SAS and Vice-President of SAS for Section III SAS (Letters of the Director of IPS SAS No. 301/2005 of 19 October 2005; No. 339/2005 of 30 November 2005; No. 340/2005 of 30 November 2005; 344/2005 of 1 December 2005; No. 350/20005 of 8 December 2005).

President of the Republic Ivan Gašparovič expressed his appreciation of the cooperation with IPS SAS in a personal letter to the Director of IPS SAS of 24 November 2005 and later also during the reception of Director of IPS SAS and prof. O. Krejčí on 6 June 2006. During the meeting, the results of the parliamentary elections in the Czech Republic and the issue of the upcoming elections to the National Council SR were analyzed. At the same time, the Head of state was informed about the preparation of a more broadly conceived international project "Memorable Days of Alexander Dubček", which was to be undertaken on the occasion of the 85th anniversary of his birth. On this occasion, the President was asked to take the patronage of the event, which he accepted.

4. Cooperation with the National Council of SR

In addition to the work of Dr. L'uboš Blaho at the Secretariat of the President of the National Council SR, cooperation developed with the Foreign Committee of the Slovak National Council and its President Boris Zala. From the summer of 2006, on the floor of the Secretariat of the Committee, meetings were held to ensure the preparation of the international academic conference "Alexander Dubček – a prominent Slovak and European" and the participation of foreign guests. Alongside IPS SAS, representatives of the Trenčín University of Alexander Dubček, the Alexander Dubček Society, A.S.A. and the village of Uhrovec took part in them. (6/9/2006; 8/9/2006; 13/9/2006; 12/10/2006; 22/11/2006).

On the request of President of the Foreign Committee of the Slovak National Council Boris Zala of 8 September 2006, the Secretariat of the Committee received book publications form the production of IPS SAS (Letter No. 1217-27/2006 ZV NR SR).

5. Cooperation with the Ministry of Culture SR

On 24 November 2004, under the auspices of Minister of Culture Rudolf Chmel, a conference was held under the title "Laco Novomeský – politician in culture, cultured politician" in the Slovak National Museum in Bratislava. Its expert guarantor was IPS SAS. The publication of the collection of papers under the same title by VEDA – Publishing House of SAS was made possible through the financial contribution of the Ministry of Culture. Minister of Culture Rudolf Chmel also financially contributed to the publication of another book title produced by our insitute - Pavol Lukáč: "Milan Hodža v zápase o budúcnosť strednej Európy v rokoch 1939 – 1944" ("Milan Hodža in the struggle for the future of Central Europe in 1939-1944). On behalf of the prematurely deceased author it was edited and prepared for publication by JUDr. Štefan Šebesta and prof. PhDr. Pavol Petruf, DrSc. (Letter of the Director of SAS No. 142/2005 of 16/5/2005).

Summary

In the previous years, IPS SAS has achieved a special position in the cooperation with the decision-making bodies due its orientation towards "live" politics and contacts with the highest state representatives. The degree of this cooperation did not result from the initiative of the management of the institute and its founding charter but predominantly from the preeminent interest of the Foreign Ministry, Ministry of Defense, the Government Office, the Office of the President SR, the National Council of the Slovak Republic, the Ministry of Culture and their representatives in the application of the latest results of the research activity of IPS SAS in political practice. Thus, financial resources invested in the research into political science have returned to the state in a tangible form.

As known from the 2000-2003 Accreditation Report of the IPS SAS (pp. 19-20), our institute achieved remarkable results in this area. Evident increase in the academic output in the form of book production has called forth a new approach to the presentation before expert and general public. In 2000, IPS SAS began to cooperate on a systematic basis not only with printed but also with electronic media, particularly with the Slovak Radio.

The IPS SAS research workers frequently spoke in a radio program "Historia magistra vitae" on the Devin radio channel (reporter Dr. Táňa Kusá) and in the program "Contact Studio" (Mgr. L. Mrázová). The latest results of interdisciplinary research into social processes of IPS SAS and humanities research base were presented both on the radio and in newspaper articles. Furthermore, the institute directed its attention towards discussions on major social-political subjects in an effort to raise the general public's awareness of their significance. In this respect, IPS SAS took deliberate steps to create an integrated conception of the institute's presentation in the media in compliance with the current requirements of the social and political life.

The "SAS Award for the popularization of science" signifies the quality of promotion of academic results of the IPS SAS research workers jointly with the Slovak Radio. The SAS Presidium gave this award to two Slovak Radio reporters - Dr. Táňa Kusá in 1999 and Mgr. Lýdia Mrázová in 2003. The media presentation of IPS SAS was equally appreciated by the SAS Presidium (Minutes of the 35th session of the Presidium of SAS of 24 June 2003, resolution No. 669, p.7)

Probably the most significant output both in terms of the popularization of science and application for 2003 from the general public's perspective was a year-long radio series "The road to independence in the documents of the Slovak national identity and statehood," broadcast on the occasion of the 10th anniversary of the establishment of the Slovak Republic prepared jointly with the editorial staff of the "Contact Studio SRo" and moderated by Mgr. Lýdia Mrázová. In the regular Monday radio program of Contact Studio (10:30-12:00), individual parts of the series were broadcast, leaning on the publication "Documents of the Slovak national identity and statehood", whose guarantor was IPS SAS.

Each part of the series consisted of the following parts:

1) An extract from a historic document (read by an actor)

- 2) A presentation by the authors of the book introduced and commented on by the reporter (Mgr. L. Mrázová)
- 3) A guiz question for the listeners.

Three correct answers to the question were determined by lot in the following week and the winners received book titles from the production of IPS SAS – "The Slovak National Council"; "The struggle for Slovakia and Trianon (1918-1920)"; Milan Hodža – statesman and politician (a total of 150 copies). In addition, Contact Studio announced that towards the end of 2003, from all the authors of the correct answers, the overall winner chosen by lot would win an international sightseeing tour for two. This took place on 20 December 2003 with the participation of the General Director of the Slovak Radio PhDr. Jaroslav Rezník, who highly appreciated the whole series and expressed his wish that a similar series be broadcast by the Slovak Radio in 2004.

On the basis of letters and emails sent to the Contact Studio (approx. 2200), it may be stated that the series "The Road to independence in the documents of the Slovak identity and statehood" received an exceptional response from the listeners. As a result, a special discussion was held in the middle of the series (on 28 July 2003) on this program with the participation of M. Pekník, M. Podrimavský and D. Čaplovič. The guarantor of the project was PhDr. Miroslav Pekník, CSc. (See Letters by the Director of IPS SAS No. 58/2003 of 21 December 2003; No. 109/2003 of 7 April 2003; No. 193/2003 of 18 June 2003).

Based on the agreement with the Editor-in-Chief of the periodical "História, revue o dejinách spoločnosti" PhDr. Vladimír Segeš, PhD., the radio series "The Road to independence in the documents of the Slovak identity and statehood" was presented under the title "Drawn from the ether" in the section of this periodical entitled Interview/documents and sources.

For the year-long radio series "The Road to independence in the documents of the Slovak identity and statehood" the Presidium of SAS gave its authors "The SAS award for the popularization of science" in 2004.

In 2004, hand in hand with the work on the projects within the state programs, media presentation of academic outputs of IPS SAS acquired a new dimension. Also on the suggestion of the Presidium of SAS, we decided to revise our media conception and present the selected research results in concert with other organizations working on the project, particularly with the Slovak Radio Media Research Department, Alexander Dubček's society and others. Due to the significance of the events and the favorable response from the public, we organized our press conferences on the results of the State research and development program on 15 March, 29 April and 16 December, in the conference hall of the Slovak Radio with the participation of 50-60 people.

We used a similar approach in presenting books from our production. Presentation of the publication "Revolutionary and anti-totalitarian movements in Europe after WWII" took place in the congress hall of the Kyjev Hotel. 130-150 Alexander Dubček followers and admirers took part in the event. The publication "Formation of the Slovak diplomacy in 1990-1993 was presented in the congress hall of the Ministry of Foreign Affairs SR with the participation of Minister Eduard Kukan (70-80 participants). By this publication, the agreement on cooperation and mutual support between SAS and the Ministry of Freign Affairs found its practical fulfillment.

The events both in the Slovak Radio and in the Ministry of Foreign Affairs took place under the umbrella of the Presidium of SAS represented by PhDr. Ivan Sarmány-Schuller, CSc., Ing. Vladimír Hák, PhDr. Milan Zemko, CSc., which created the room for the promotion of SAS as a whole. This was a new approach in the institute's media presentation, which was reflected in the establishment of a new position – IPS SAS PR/media secretary.

Expert knowledge and skills gained form the work on the VEGA grant projects of the Ministry of Education and SAS concerning the issue of politics and media allowed us to avoid stereotypes and change the methods and focus of the media presentation of IPS SAS. If in 2004 we put emphasis on large-scale press conferences and their news coverage through agencies, in the next period, 2005-2006 we chose a different approach. Live discussions with representatives of IPS SAS shortly before the main evening news ("At first hand", "Contact Studio" on the radio) or speeches and discussions broadcast in prime time (on TV) were given priority. As an example, in the first half of 2006, we produced a series on parliamentary elections from the period of L. Štúr up to the present day. We took into account the timing, the type of the program etc; our research partner – the Slovak Radio Department - lent a helpful hand. In this manner, the media policy of IPS SAS aimed at its presentation and promotion became much more efficient in terms of its target audience. To this effect we used the so-called multiple presentations on the same subject in the course of several hours in several media (the Slovak Radio, TA 3 TV channel). IPS SAS also took part in the media campaign of the Prime Minister's Office on the event "Milan Hodža Days" in 2005-2006 in Martin.

Thus, it may be stated that IPS SAS has gradually created its own conception of media presentation and other activities aimed at the popularization of science, which made our institute known not only in expert circles but also in broad public. This has found a significant response in the public's interest in our book publications, which were produced as outputs from the projects of state programs "Ideological sources and currents of Slovak politics" and "Transformations of the identities in the current and historic context of Slovakia with regard to the integration processes." These publications

iii. Status and development of research infrastructure incl. experimental, computing and technical base (description of the present infrastructure, premises, and material and technical resources. Computer equipment in the workplace is currently on an average level. Each worker has access to a computer and the Internet. There are ten desktop computers and one notebook at the institute, which is currently insufficient. The optimum is one notebook per research worker at their permanent disposal. In October 2004, the obsolete coaxial network of 10 Mb/s was replaced by structural cabling of 100 Mb/s. Security within the intranet is provided by a Firewall on the entrance to the LAN. In the near future, IPV SAS will have to solve the capacity problem of the network connection as only one is free at the moment. This problem can be solved by a wireless connection into the existing structural cabling.

Last year, the institute purchased a Benq720P projector and an adequate projection screen. Power Point presentations are becoming increasingly commonplace and they are also used by some of our workers. By providing the projector, we intend to bring more quality into the standard provided at the academic events organized by IPS SAS.

The next investment intention in the area of computer technology in IPS SAS is technical equipment enabling the organization of video-conferences. To this effect, a 42inch TV-set, a high-performance computer and a camera and software equipment are indispensable. These intentions will be consulted with the Computer Centre of SAS, which has always provided us with the necessary information.

Another investment project that will probably be undertaken in 2007 will be the purchase of one xerox copier machine, as annual repairs and maintenance account for a significant portion of the financial resources.

It is the institute's ambition to sustain the standard equipment of IPS SAS by means of the allocated financial capital resources.

iv. Status and development of bibliographic resources, activities of the Organisation's library and/or information centre

In 2003-2006 Mrs. Dagmar Kubíková, one person employed for a full salary, worked in the library. During this period she supplied 13 341 library-data services, i.e. 3335.25 services

per year. Furthermore, she has been retrieving research data from daily press, periodicals and literature on the selected issues for the needs of the IPS SAS workers.

By 31st December 2003, there were 2969 books in the library fund of IPS SAS. In 2003 IPS SAS obtained 64 book titles as a present from the following subjects: IPS SAS workers, CL SAS, Constitutional Court of SR and ÚSD AV of the Czech Republic. Owing to the lack of financial resources, the institute did not purchase a single book title. All the financial resources were used for the purchase of periodicals. By 31st December 2004, the number of book titles increased significantly. At that time the institute owned 3253 books. In 2004, IPS SAS bought 264 books and received 10 books as a present. The financial resources were also used for the purchase of 24 titles of periodicals. By 31st December 2005, there were 3329 publications in the library fund. In 2005, IPS SAS bought 8 books and received 68 books as a present. The financial resources were also used for the purchase of 19 titles of periodicals and 4 titles as as present. By 31st December 2006, the number of books increased to 3434. In 2006, IPS SAS bought 102 books and received 13 books as a present. The financial resources were also used for the purchase of 15 titles of periodicals and 3 titles as a present. There are 10 000 pages of xeroprints of documents of The Governmental Committee for the Analyses of Historical Events between 1967 and 1970 in the IPS SAS archives.

Part of the personal archives of Dr. Martin Kvetko from the period of 1948-1990 is stored in IPS SAS. PhDr. Jozef Jablonicky, DrSc. saved and transferred it to the institute from New York. On 4th June 2003, Dr. Vojtech Čelko from ÚSD AV of the Czech Republic presented to IPS SAS a total of 36 letter units of the correspondence between Mr. M. Haviar and Mr. J. Lettrich in xeroprint. The archives of IPS SAS include unpublished reflections and memories of doc. PhDr. Ján Uher, CSc., which he donated to the institute in person. In the course of 2003, a collection of materials of PhDr. Jozef Jablonicky, DrSc. dealing with his activities in the normalization period, were collected and compiled. Materials from the collection were also used in the publication dedicated to Dr. J. Jablonicky "I saw the light and I do not want darkness any more..." published in 2005 by IPS SAS in VEDA – Publishing House of SAS. The materials of Dr. Jozef Jablonicky were also used in the publication "Jozef Jablonicky: The Samizdat about the revolt II. Studies and the Articles. Bratislava, Kalligram 2006, 712p. The library fund of IPS SAS and the collections in the archives were used by IPS SAS workers, students of the Faculty of Philosophy CU Bratislava, students of the Trnava University Trnava and workers of IH SAS in 2004.

In 2004, the library fund of IPS SAS and the archive collections were used by Professor Owen V. Johnson from Indiana University, USA; Dr. Vojtech Čelko from the Institute of Contemporary History AS CR, Prague; Dr. Jaroslav Pažout from the Central State Archives in Prague; research workers of IH SAS, PhD. student from the Department of

History of FHV UMB Banská Bystrica Mgr. Marek Syrný and the students of the Faculty of Philosophy, CU Bratislava.

Likewise, in 2005 the library fund of IPS SAS and archive collections were used not only by the workers of IPS SAS, but also by the following subjects: Dr. Vojtech Čelko from the Insitute odf Contemporary History AS CR; Dr. Jaroslav Pažout from the National Archives in Prague; workers of FF PU Prešov, FMV EU Bratislava, VHÚ Bratislava, IH SAS and students from the Faculty of Philosophy, UKF Nitra and the Faculty of Philosophy CU, Bratislava.

In 2006, the library fund of IPS SAS and the archive collections were used not only by the workers of IPS SAS, but also by Dr. Vondrová and Dr. Vojtech Čelko from the Insitute of Contemporary History ASCR; Mrs. Lýdia Kokavcová from the Slovak Television Bratislava; Mgr. Mateusz Gniazdowski from the Polish Institute of International Studies, Warsaw; Mgr. Natalya Lazar from the Fedkovych National University, Chernivtsi (Ukraine, the studies in Slovakia based on the scholarship of the International Visegrad Fund); Dr. Jaroslav Pažout from the National Archives in Prague; Dr. Jiang Li from Chinese Academy of Humanities in Beijing. Between January and June 2006, the library fund and archive collections of the daily press were used by the students – interns of FF UKF Nitra. The documents of the Governmental Committee were studied in 2006 also by Otakar Kořínek, who published a book "The Invitation Letter 1968" in PT Publishers, 2006.

Evaluation of Section III - Humanities and Social Sciences Institutes of the Slovak Academy of Sciences

Evaluation of Section III - Humanities and Social Sciences Institutes of the Slovak Academy of Sciences (III-HSSI SAS) took place at Smolenice on 12-14 February 2006. The IPS SAS was ranked 16th in the Overall Summary Evaluation Report. The leadership of the Institute described this decision as biased and appealed against it in Letter No 59/2006 of March 3 2006 and, following its rejection, in Letter No. 74/2006 of March 27 2006 supplemented with an analysis entitled "Official statement on the evaluation of the Institute of Political Science SAS for 2005". The letter of appeal was sent to PhDr. Dušan Kováč, DrSc. Vice-Chairman of the SAS for III-HSSI SAS, Chairman of the Evaluation Commission for III-HSSI SAS and PhDr. Dagmar Podmaková, CSc., Vice-Chairman of Chamber III of the SAS Assembly.

The outcomes of the evaluation of III-HSSI SAS triggered a response not only from the Institute of Political Science SAS but also from other institutes. The Institute of Philosophy SAS and the Jan Stanislav Institute of Slavistics expressed their own reservations about the course, criteria and evaluation process. The issue of evaluations was successively discussed at the session of the HSSI Chamber III of the SAS Assembly, at the Assembly itself and was dealt with by SAS Chairman Prof. Ing. Štefan Luby, CSc. During the talks with the SAS Chairman, under the pressure of presented arguments, representatives of the administration of III-HSSI SAS had to admit that they had made some mistakes during the compilation of the background data. The enclosed letter of appeal sent by the IPS SAS was submitted as evidence material.

OFFICIAL STATEMENT ON THE EVALUATION OF THE IPS SAS FOR 2005 (Letter of Appeal)

The material was prepared in compliance with the official criteria of III-HSSI SAS. The enclosed tables were compiled by PhDr. Dušan Gálik, CSC., member of the IPS SAS, who based his work on the background data.

We analyzed four areas:

- I. Position in the scientific discipline/disciplines
- II. Popularization and practical application
- III. Projects and other extra-budget resources
- IV. Educational activity

Of these, in compliance with the set criteria, comparison was made in areas II - IV between the results from the *Report on the Activity of the IPS SAS for 2005* and those from Reports for 2005 of those institutes which were rated the highest by the "Evaluation Commission for HSSI SAS".

I. Position in the scientific discipline/disciplines

Following the submission of data on the evaluation of the IPS SAS, we found that the figure on the number of doctoral supervisors was incorrect. We informed Dr. Gálik about this mistake in the letter of 20 February 2006. The letter was sent after this fact had been pointed out at Smolenice. If the wrong number had been corrected, the resulting coefficient in this area would be 3.11, which is a figure higher than the average for all institutes (2.97). During the evaluation process, the IPS SAS fully respected the criteria set by the administration of Section III - HSSI SAS; this also applies to the area of "Position in the domestic context". Yet, we firmly believe that

the set criteria do not reflect the real position of the institute in question, which we would like to discuss in more detail in the text below.

In 2005, in addition to the VEGA grant projects IPS SAS also worked on two other projects within the state research and development programs and participated in another project undertaken by the ISS SAS.

Officially, the participation in the project entitled "Ideological resources and lines of the Slovak politics" of the state research and development program "The role of the social sciences in the development of society" was 58 research workers (the real figure was more than 70 - see the breakdown of financial resources). Besides individual participation, a total of 19 organizations took part in the state program research project. Many of them signed contracts with us. Furthermore, we cooperated with the following academic and university institutions: The Institute of History SAS, The Institute of Philosophy, The Institute for Forecasting, the Faculty of Political Science and International Relations UMB, Banská Bystrica; Department of Political Science, Faculty of Philosophy, Prešov, the Institute of History of the Faculty of Philosophy, Prešov, Department of Political Science and European Studies, Faculty of Philosophy UCP, Nitra, Department of Political Science, Faculty of Philosophy, UCM Trnava; Department of Political Science, Faculty of International Relations, Bratislava; Slovak History Department, Faculty of Philosophy, Bratislava; Department of General History, Faculty of Philosophy, Bratislava; Department of Sociology, Faculty of Philosophy, Bratislava.

Cooperation with the selected university institutions was also provided by "Framework agreements on cooperation". These institutions included Department of Political Science and European Studies, Faculty of Philosophy, UCP Nitra; Department of Political Science, Faculty of Philosophy, UCM Trnava; Department of Political Science, Faculty o Philosophy, the Prešov University; Department of political science, TUAD, Trenčín; Department of Political Science, FMVZ EU, Bratislava. Pursuant to these agreements, our cooperation continued even after the completion of the project of the state program in 2005.

In this manner, the IPS SAS coordinated at least two thirds of the overall volume of political science research in Slovakia under the project "Ideological resources and lines of the Slovak politics" in 2005.

Only two departments of political science (at the Faculty of Philosophy, Bratislava and the Faculty of Philosophy, TU, Trnava) did not take part in the research; the above-mentioned institute in Bratislava worked on its own project within the state research and development program.

- 2. The project entitled "Transformation of the identities in the present and historic context of Slovakia with regard to the integration processes" within the subprogram entitled "The implementation of outstanding projects in support of the professional growth of young research and development workers and doctoral students", of the state research and development program "Encouragement of personality growth and talent of young research and development workers and doctoral students under 35 " was, in addition to the IPS SAS (33 research workers), also participated by the Institute of History SAS (8 research workers) and the Institute of Ethnology SAS (3 research workers). Academic results of the conferences included the participation of other research workers. The result was a collection entitled "Theoretical approaches to identities and their practical applications."
 - 3. The project *Nation, nationalities and ethnic groups in the transforming society* of the state research and development program "The role of social sciences in the development of the society" was participated by three research workers from the IPS SAS. The project was undertaken by the Institute of Social Sciences SAS in Košice.

- 4. In 2005, the IPS SAS ÚPV SAV organized, or co-organized, the following academic events:
 - The Days of political science in Prešov. Topic: Civic society and national identity in the process of European integration. Prešov. Co-organizer: IPS SAS 7 8 April 2005 Audience: 50 people.
 - Academic conference "Transformation of identities in the present and historic context of Slovakia with regard to integration processes". IPS SAS, IE SAS, IH SAS, Bratislava, 15 16 June 2005, Audience: 60 people.
 - "Milan Hodža and the integration of Central Europe". International academic conference held under the auspices of the Prime Minister of the Slovak Republic. Organizers: IPS SAS, IH SAS, Martin, 24 June 2005, Audience: 150 people.
 - "The Czech-Slovak relations, the Slovak-Czech Relations". The Liberec seminar. Liberec 25- 26 August 2005, co-organizer IPS SAS, 80 participants.
 - "Transformation of the foreign political priorities of the SR following its entry into the EU" 30 September 2005, Bratislava. Organizers: IPS SAS, Central and Eastern European Society, FSES UK, Bratislava, Audience: 60 people.
 - "MUDr. Vavro Šrobár politician, journalist and educationalist". International academic conference held under the auspices of the President of the Slovak Republic. Organizers: IPS SAS, HIS SAS, FP UK Bratislava, 25-26 October 2005. Total audience: 300 people, of these two thirds were students.
- Academic conference "Ethics and Politics". The Trenčín University of Alexander Dubček. Co-organizer: IPS SAS, 14 November 2005, Trenčín. Audience: 120 people.

Conclusion

If we summarize the range of academic and research activities of the IPS SAS in the Slovak Republic, it becomes clear that the table criteria set by the Section III - HSSI SAS for determining the position (ranking) in the academic discipline do not take into account the facts that we have submitted.

II. Popularization and practical applications

On revising the data on popularization from the IPS SAS table, we identified the following mistakes:

In both years individual items were calculated incorrectly and their sum for 2004 was divided by an incorrect total of 17 academic workers and in 2005 by 14 academic workers; meanwhile, the number of academic workers of IPS SAS was 9. The mistake is visible at first sight since a higher number of events has a lower coefficient.

Applications

- 1. On 20 February 2006 we sent our objections to the evaluation procedure to Dr. Gálik. We pointed to the fact that we had prepared a total of 31 expert reports for the President's Office; they are listed on pp. 28-30 of our *Report on the Activity of the IPS SAS for 2005*, Chapter XII. We refer to it also in Chapter VI, p. 18, line 1.
- 2. The text below the evaluation table on the application and popularization states that expert activity of the institute is included in the applications category. *Report on the Activity of the IPS SAS for 2005,* p. 18 states explicitly that
- JUDr. Šebesta is an external advisor to the Minister of Foregin Affairs of the Slovak Republic,
- *PhDr. Jaššová* is an expert on social communication and cooperates with the Ministry of Work and Social Affairs and the Parliament of Roma Settlements (the Report even includes the exact dates).

This constitutes a total of 33 particular applications, which are listed in the summary report. These data were omitted from the evaluation.

- 3. In addition to the above applications, following the request made by the President's Office of the SR, the IPS SAS prepared and organized two "expert round-table meetings" with the President of the SR, which were held on 9 February 2005 and 13 April 2005 (Report on the Activity.. p. 28).
 - 4. The following book monographs were also left unnoticed:
- Mojžita M. Formovanie slovenskej diplomacie v rokoch 1990 až 1993. Kňažko Demeš
 Kňažko (Formation of the Slovak Diplomacy in 1990 to 1993. Kňažko Demeš Kňažko)
- Krejčí O. Geopolotics of the Central European Region. The view from Prague and Bratislava,

which were sent to the President's Office of the SR, to the Ministry of Foreign Affairs of the SR and to the Ministry of Defence of the SR on request; the total number of copies was 520. These were intended both for practical application and for representation abroad through Slovak foreign representative offices.

After the inclusion of the above-mentioned facts and the comparison of our data with the data from the annual activity reports of two highest-ranking institutes in the area of Popularization and practical application – Institute of Theatre and Film and Institute of Sociology we obtained the following coefficients:

Conclusion

The coefficients thus obtained imply that IPS SAS should have obtained the evaluation coefficient of 24,21, and not the declared 13,9. This, however, does not correspond with IPS's 7th position in the respective table. The application outputs in book form intended to promote Slovakia abroad through foreign representative offices were not taken into account at all. The 7-position difference between the real coefficient and the point evaluation scheme of the commission is thus inadequate.

III. Projects and other extra-budget resources

Comparison of the volume of financial resources gained from the projects per one research worker with that of institutes ranking first, second and third in the evaluation table.

Conclusion

The institute's real position in terms of the gained volume of extra-budget resources per one research worker is in contradiction with its ranking as 19, which is n alleged penultimate position.

In 2005, the IPS SAS did not need any finances from foreign resources - both the expenses for their own research work and those for the work of their cooperating institutions were covered by domestic grant projects.

Since at present, the Slovak crown is a freely convertible currency, the volume of finances should be equal with the resources allocated for international projects. Similarly, the principle of automatic superiority of international projects over domestic projects regardless of their quality is, in our opinion, not correct.

The projects, which within the set table criteria of Section III HSSI SAS were divided into domestic and international, are presented as one overall figure, without further specification. This problem was also mentioned in the letter to the Vice-Chairman for Section III HSSI SAS by the Director of Jan Stanislav Institute of Slavistics (email of 10 March 2006). It is not clear from the table criteria which factor is decisive in the projects – whether their number, the number of participating researchers or the volume of gained resources.

We are firmly convinced that it is the quality of the draft proposal of the project and its subsequent implementation in the form of reviewed academic output that should be the most decisive evaluation criterion. Under such circumstances the institute would have no difficulty in withstanding international competition regardless of whether it used finances from domestic or from foreign resources. The latter, although necessary for the basic research, do not have a significant influence on the quality of academic work of the institute in question. These aspects of project evaluation were not taken into account in the table criteria set by Section III HSSI SAS.

In this respect we would like to point out that the IPS SAS was actively involved in the international cooperation even without drawing financial resources either within the Framework agreements on cooperation with foreign partners, or on individual basis. The following aspects of our activity were not considered:

- a) Individual projects

IV. Educational activity

Having compared data on doctoral study with three best-ranking institutes in the area of educational activity, we obtained the following data:

Conclusion

Evaluation on the basis of the criteria set by Section III-HSSI SAS disagrees with the 9th position of IPS SAS.

The following results of the institute's activity were not taken into account:

a) In the academic training process, a total of 33 doctoral students and young research workers of the IPS SAS succeeded in carrying out an independent project under state research and development program "Transformations of identities in current and historic context of Slovakia with regard to the integration processes" within a subprogram entitled "The implementation of outstanding projects in support of the professional growth of young research and development workers and doctoral students" of the state research and development program "Encouragement of personality growth and talent of young research and development workers and doctoral students under 35". 8 doctoral students from the IHS SAS and 3 doctoral students from IE SAS joined the project.

Their activity resulted in 2 academic events and 3 academic publications in 2005. Further publications resulting from the project are now in print.

b) Educational activities of the IPS SAS outside doctoral study were performed in cooperation with the following universities and institutes within the signed "Framework agreements on cooperation"; they included other areas of cooperation as well: UCM Trnava, UKF Nitra, TU AD Trenčín. PU Prešov.

A special example of educational activity in 2005 was a joint organization of three academic events with the participation of students from Faculty of Philosophy of the Prešov University in, Prešov, the Faculty of Philosophy UK Bratislava and TU AD Trenčín.

- The Prešov Days of Political Science, Prešov 7-8 Apríl 2005,
- MUDr. Vavro Šrobár politician, journalist and educationalist, 25 26 October 2005, Bratislava.
- Ethics and Politics, 14 November 2005, Trenčín.

NB: In this context, we consider it unusual that, in some cases, those HSSI. which did not organize doctoral study at their own institutes but only participated in the doctoral supervision elsewhere, on an extramural basis at universities, received a higher ranking. The Institute of Philosophy SAS referred to this circumstance in a letter of 6 March 2006. It seems that greater emphasis was put on lecturing activity in universities and on the supervision of Master's dissertations than on intramural doctoral study and defended doctoral theses. However, the evaluation table on academic training does not contain such criteria. The issue of Master's dissertations is dealt with in a separate evaluation table – "Position in the domestic context."

Auxiliary evaluation criteria

The leadership of Section III SAS also sent auxiliary tables to the SAS institutes with the following heading: "Staff – qualification structure". In this context we consider it necessary

to remind that for two successive years (2004-2005), the problem persisted with insufficient volume of financial resources for tariff salaries. Owing to the fact that the IPS SAS did not receive the necessary financial resources for the approved limit of 15 workers for the whole course of 2005, the Scientific Board of IPS SAS addressed this situation at its session on 5 December 2005. The enclosed resolution of the Scientific Board of IPS SAS was sent, along with Letter No 347/2005 of 5 December 2005, to PhDr. Dušan Kováč, DrSc., Vice-Chairman of Section III-HSSI as well as for the information of prof. Ing. Štefan Luby, DrSc., Chairman SAS. At the same time, the IPS informed the Committee of the SAS Assembly through PhDr. Dagmar Podmaková, CSc., Chairman of Chamber III of the SAS Assembly.

Resolution of the Scientific Board of IPS SAS of 5 December 2005.

- 1. Besides its research activity at its sessions, the Scientific Board IPS SAS (SB IPS SAS) is forced to deal with the personal provision of research and the related financial issues.
- 2. SB IP SAS states that, as a result of insufficient salary funds, the situation at IPS SAS has been highly critical for the second consecutive year. The allocated salary fund does not cover even the most essential needs of the institute in the area of tariff salaries since out of the necessary 3 713 thousand SKK for 2005, 128 thousand SKK is still missing, which results in the repeated layoffs of staff members. We further remind that the Director of the IPS SAS cannot pay bonuses or extra pays as even the tariff salaries stipulated by the employment contracts are not covered.
- 3. SB IPS SAS expresses its concern and discontent over the lack of response from the SAS Presidium to numerous requests and suggestions despite enormous effort made by the Director of the IPS SAS.
- 4. The steps taken hitherto by the SAS Presidium are inadequate to the results of the institute in the research area, in organizing research teams of internal and numerous external workers, in the coordination of research in two extensive projects of state programs. The institute has also achieved outstanding results in academic training; in less than two years (September 2003-June 2005) seven doctoral students defended their theses.
- 5. SB IPS SAS fully identifies with the existing policy of the Director of IP SAS. It expresses support to his further steps in striving to meet the demands of the employees for tariff salaries within the approved limit of workers.
- 6. We remind that although the SAS Presidium has committed itself to endorsing research into political science by Resolution No 208 of 7 February 2002, this resolution has not been carried out.
- 7. SB IPS SAS expresses its concern that leaving the existing situation unresolved poses acute danger of stagnation and stifling of research in political science instead of further socially desirable and relevant development. Therefore, SB IPS SAS demands that the Presidium SAS address this problem and call the Director if ISP SAS to take part in the discussions. At the same time, it demands that the Director inform the Committee of the SAS Assembly about this situation in writing through PhDr. Dagmar Podmaková, CSc., Chairman of Chamber III of the SAS Assembly.

The Resolution remained unanswered by the SAS Presidium. The answer came only from the Committee of the SAS Assembly in Letter No 1/2006 of 9 January 2006, which stated that: "The Committee of the SAS Assembly dealt with the issue at its session on 19 December 2005. Notwithstanding the seriousness of the problem and rightfulness of your

claim, the Committee of the SAS Assembly has arrived at the decision that it is not entitled to resolve the issue, and proposes to pass your appeal to the Vice-Chairman of Section III HSSI SAS...". (Letter by the Chairman of Chamber III of the SAS Assembly No 1/2006 of 9 January 2006).

Summary

The analysis of the evaluation of the IPS SAS implies that, as regards the institute's performance, criteria set by the leadership of Section III-HSSI were not applied in many respects. During the evaluation, major shifts occurred when results of the activity of the IPS SAS were compared against those achieved by other institutes of Section III HSSI SAS in three outof six evaluation areas. As a result of this, the overall rating of IPS SAS was 16.

The facts from the Report on the activity of IP SAS for 2005 fully confirmed our argumentation. Thus, the annual evaluation for 2005 harmed the reputation of IPS SAS. The issue of allocation of financial resources is less important. We demand therefore that the leadership of Section III-HSSI take a firm stance on our appeal appropriate to the seriousness of the situation created by the evaluation for 2005 and rectify the mistake.

Personnel and salary issues

Early in 2006, at the session of the Academic Board of IPS SAS, which evaluated the Activity Report of IPS SAS for the previous year, the Director of the institute stated that all available means were used to gain financial resources to cover tariff salaries. He also said that if the Presidium of SAS did not change its stance on the salary policy of IPS SAS, the institute might expect that in the course of 2006 the institute's academic production would reduce and young research workers would gradually leave SAS.

Consequently, as was the case in the previous years, IPS SAS could not reach its approved staff limit. This deficit constituted 1.5 to 2.5 of the workforce during the first half of the year.

Salary revision as at 1 March 2006 showed that the need for due tariff salaries for 2006 in the amount of SKK 212 000 was not met. Following the valorization as at 1 July 2006, the difference increased even despite the increase in salary resources of SKK 142 000.

The suspected negative impact especially on the former intramural doctoral students proved true. Over the last four years, 8 intramural doctoral students finished their study. Of these, five received a symbolic short-term work load. Their work load as at 31 December 2006 constituted a total of 1.03 of the work force.

The savings of salary resources at the end of the year due to incomplete staff in the amount of SKK 58 000 were allocated and distributed as bonuses. The average amount of bonuses was less than SKK 4 000 per staff member.

Owing to the conceptual and organizational changes in the Slovak Radio as a project partner, in the latter half of 2006, PhDr. L'udmila Benkovičová, CSc. was employed on a part-time basis to ensure the continuity of sociological research into public opinion. The current growing need to publish academic outputs in English has been covered by the admission of PhDr. Elena Klátiková. To ensure the regular updates of the IPS SAS webpage and to keep the public up-to-date with the insitute's activities, Mgr. Ondrej Červený was admitted to the institute as an IT specialist. Thus, in the latter half of 2006, the staffing reached its limit.

Owing to the gradual reduction of the work load of the reserach workers in the retirement age, the average age of the work staff has slightly declined compared to the previous year, even though the average age of the backbone staff is growing.
